LEANNE G. SPENCER'S CONSENT MOTION FOR EXTENSION OF TIME TO RESPOND TO OFHEO'S SECOND SET OF DOCUMENT REQUESTS TO RESPONDENTS

Respondent Leanne G. Spencer ("Spencer"), through counsel, hereby moves on behalf of all Respondents for an extension of time, until March 13, 2007, to file Motions to Strike or Limit OFHEO's Second Set of Document Requests. OFHEO consents to this request.

OFHEO served its Second Set of Document Requests on each of the Respondents on February 1, 2007. To enable the parties to meet and confer regarding Respondents' objections to the Document Requests, the parties agreed to extend the deadline for Respondents to file Motions to Strike until February 27, 2007. Respondent Raines filed a consent motion seeking such an extension on February 15, 2007. That motion remains pending, but is rendered moot by the instant motion.

Accordingly, Spencer respectfully requests an extension of time, until March 13, 2007, for all Respondents to respond to OFHEO's Second Set of Document Requests and to Request No. 10 from OFHEO's First Set of Document Requests.¹ Counsel for Spencer conferred with
