The RFP is amended as follows:

The first sentence of L.13 (K), page 87 of 136 is changed from “The offeror shall submit two electronic copies of the proposal on CD-ROM, designating one as “back-up” (in addition to the hardcopies specified above), in the Adobe Portable Document File (PDF) format, version 5.0 or greater.” to read “The offeror shall submit two electronic copies of the proposal on CD-ROM, designating one as “back-up” (in addition to the hardcopies specified above), in Microsoft Word 2003 compatible and Adobe Portable Document File (PDF) format, version 5.0 or greater.”

NOTE TO POTENTIAL OFFERORS: As a result of this amendment, page 87 of 136 is deleted in its entirety and replaced with slip page 87 of 136, which has been posted.

All other terms and conditions remain unchanged.

The question and response is as follows:

QUESTION: In order for us to provide sufficient information in our proposal, is it acceptable to include information in a table format using 8 point font?

RESPONSE: No, Provision L.13 and L.14 are explicit in identifying font size requirements. An 8 point font can only be used to name or label figures, illustrations, tables or non-text illustrations. Proposal narrative text, including chart content text, used to reply to this RFP must be in 12 point font as specified in Provisions L.13 and L.14 of the request for proposal. If the Government determines that proposal narrative text is provided in less than 12 point font and included in tables, illustrations, graphics, or non-text illustrations, in accordance with Provisions L.13 and L.14 the pages will not be evaluated by the Government and will be returned to the offeror.
