## Summary of Significant Changes since Draft Request for Proposal (RFP) and Acquisition Highlights for the Medical and Environmental Support Contract (MESC) RFP NNK07204121R September 13, 2007

Provided below is a listing of the significant changes that have been incorporated into the final version of RFP NNK07204121R. The changes are the result of questions and comments received from industry and internal reviews performed by the Government. Offerors should examine the final RFP carefully in its entirety to discern all changes.

- 1. The Contract Line Item Number (CLIN) Structure has been revised.
- 2. The U.S. Small Business Administration's "Ostensible Subcontractor" rule, 13 CFR § 121.103(h)(4) requirements have been incorporated into provisions L.2, TYPE OF ACQUISITION.
- 3. The treatment of the phase-in period has been modified.
- 4. The Government's assessment of reasonable Award Fee percentage has been increased from 7.5% to 8.0% in Section L.
- 5. Clauses pertaining to Government Property (Federal Acquisition Regulations (FAR) part 45 and NASA FAR Supplement (NFS) part 1845) have been revised due to the FAR part 45 rewrite. When these clauses are officially released by NASA Headquarters, an amendment to this RFP will be issued with updates and clause dates. As a result, the listing of Government furnished property (attachment J-6) was revised and is now included as Attachments J-6 and J-14.
- 6. Restructure and reordering of clauses, provisions and attachments throughout Sections B thru M.
- 7. The Associated Contractor Agreement (ACA) clause has been added to Section H (Reference Clause H.20).
- 8. The Work For Others clause has been modified in Section H (Reference Clause H.19).
- 9. Instruction for the inclusion of enhancements have been added to Provision L.13(N).
- 10. Section L was revised to include instructions to the offeror to provide specific information on their proposed hazardous waste transporter and offsite treatment, storage and disposal (TSD) facility. Section M was revised to include the evaluation of this information.
- 11. PWS Section 2.3.1(p) was added to include the KSC Automated External Defibrillator (AED) policy and program management.
- 12. Section J Attachment J-8 created to list Government provided facilities available for the MESC.

- 13. Benchstock and Incumbent Contractor Owned Property standardized proposal values were updated (Reference Section paragraphs L.15 and L.17(C)(2)(e)(i)(4)).
- 14. The List of Federal Equivalencies was changed to Attachment L-11 and was updated with appropriate wage rates in accordance with the FAR.
- 15. Work load indicator's (WLI's) were updated and additional information was provided in the posted Questions and Comments, item number 54.
- 16. Clarifications were provided regarding page count for proposal submissions and the number of electronic copies (CD-ROM).
