The purpose of this Amendment 006 is as follows:

1. Provides notification of the Government's response to question 157 submitted for the final RFP pertaining to contract payments.

Question 157 is contained in a Microsoft Excel spreadsheet titled, NNX077040R RFP Questions – Posting 3. Additional questions have already been answered through prior amendments to this RFP or will be answered in subsequent amendments to this RFP, as required. The responses to the questions shall not be construed as altering the requirements of the RFP, except as specifically revised in this amendment.

2. Makes changes to Clause B.4 – Firm Fixed Price to reflect a Not-To-Exceed Firm Fixed Price to be proposed by the Offeror.
3. Amends the provisions for provisional and final acceptance of services and the payment structure for the contract by removing the Progress Payments clauses through the following:
 - a. Provides changes to Clause F.6 – Acceptance of Services;
 - b. Amends Clause G.9 – Payment and Submission of Invoices;
 - c. Removes FAR Clause 52.232-16 – Progress Payments from Section I;
 - d. Replaces page 1 of Attachment J.10 – Performance Retainage Evaluation Plan;
 - e. Replaces in its entirety DRD TM-007 – Self Assessment and Metrics Report;
 - f. Replaces Section L – Page L-1 to remove FAR Clause 52.232-13 - Notice of Progress Payments; and
 - g. Replaces pages 2 and 3 of each of the Task Order's Terms and Conditions to add a pricing table in paragraph 1 for each 6-month performance period.
4. The Due Date for Responses is not extended and remains the same.
5. All other information within the RFP remains unchanged.
