The purpose of this Amendment 007 is as follows:

1. Provides notification of the Government's response to questions submitted for the final RFP.
2. Questions are contained in a Microsoft Excel spreadsheet titled, NNX077040R RFP Questions – Posting 4. Additional questions have already been answered through prior amendments to this RFP or will be answered in subsequent amendments to this RFP, as required. The responses to the questions shall not be construed as altering the requirements of the RFP, except as specifically revised in this amendment.
3. The following changes are made to Section L and are delineated as follows:
  - a. Provides Task Order Proposal clarification for Part II, Introduction for the fourteen Task Orders and attachments.
  - b. Amends Paragraph 6.0 Volume II –Past Performance (a) (1) from “on at least 3 current contracts” to “on at least 5 current contracts”.
  - c. Amends Paragraph 7.0 Volume III – Price Proposal/ Protective Services Start Dates table by adding Information Assurance Services for Glenn Research Center to begin on 12/1/08.
  - d. Provides Task Order proposal clarification within Section 8.0 Volume IV – Model Contract and Tasks Orders.
  - e. Section L is replaced in its entirety due to the above changes as well as formatting changes throughout the document.
4. The Goddard Space Flight Center Task Order Attachment A, Performance Work Statement at Section 5.2.4.4 is changed from “HTMT” to “HMTD”. Page 28 of Attachment A PWS page 28 has been replaced in its entirety.
5. The Wallops Flight Facility Task Order Attachment A, Performance Work Statement at Section 5.2.4.4 is changed from “HTMT” to “HMTD”. Page 25 of Attachment A PWS page 25 has been replaced in its entirety.
6. The Due Date for Responses is not extended and remains the same.
7. All other information within the RFP remains unchanged.
