About the Cover:

Research on asthma has traditionally focused on children, but asthma in adults is a public health issue of increasing concern. Our cover highlights the issue: Against a backdrop swirling with exhaust, it shows the inflamed airways of an adult asthma sufferer. Studies of asthma in children have found an association between urban environments and the prevalence of the disease. But this month's feature article, "Community Urbanization and Hospitalization of Adults for Asthma," which looks at rates of asthma hospitalizations among adults in six Pennsylvania counties, reports some unexpected findings: While in some counties urbanization was associated with increased rates of hospitalization, in other counties-those with depressed socioeconomic conditions-hospitalization rates actually increased as urbanization decreased.
