The National Aeronautics and Space Administration (NASA), Lyndon B. Johnson Space Center (JSC), is soliciting proposals for the JSC Administration Support Services (JASS) Contract. This RFP replaces the Draft RFP which was released on June 17, 2008. Any questions received as a result of this RFP will be addressed as an amendment to the RFP.

This procurement is an 8(a) Set-aside competitive procurement and has been assigned NAICS code 561410 and a size standard of \$6.5M. It is contemplated that a commercial, single award, Indefinite Delivery Indefinite Quantity, Firm-Fixed Price Contract will result from this solicitation.

Offerors are responsible for ensuring that all Volume II Past Performance data are received by Ms. DeNardo no later than 1:30 p.m., CDT, August 21, 2008. Note: Past Performance questionnaires must be submitted by the respondent directly to Diana DeNardo per instructions on the questionnaire.

Proposals shall include three original signed 1449 forms properly completed with offeror's company name; complete address, including street, city, county, state, and zip code; name, telephone and fax numbers, and e-mail address of responsible person or persons; acknowledgment of amendments and signature of authorized person.
