SUBJECT: Release of KNPR 8715.3, Revision G and Implementation of a new NASA-KSC Fall Protection Policy

On November 14, 2008, KSC released KNPR 8715.3/KSC Safety Practices Procedural Requirements, Revision G. The clause KSC 52.242-90, CONTROLS APPLICABLE TO CONTRACTOR'S ACTIVITIES (OCT 2007) requires compliance with the revision of this document at time of contract award and subsequent revisions. Revision G includes extensive changes for a new comprehensive Fall Protection Policy. This policy does not replace the Occupational Safety and Health Administration (OSHA) regulations, but strengthens KSC's fall protection programs. The purpose of this notice is to ensure that potential KSC Contractors are aware of this new revision and the extensive changes it makes.

- 2. Sheet 5 (A-1), *Demolition* Note 8, is removed in its entirety. (changed item)
- 9. Sheet 27 (E4), Lighting Fixture Schedule, Type "F" fixture is removed; there are no type "F" fixtures in this project. (added item)
- 10. Sheet 11 (A-7), Flag Notes 21 24 are amended to remove "GFE" reference. (added item)
- 11. Sheet 21 (A-7), Plumbing Fixture Schedule, in the GFE column all shall be changed to "N" except for IM-1, Ice Machine, which will remain "Y". (added item)

Specification 79K38323, titled "Hangar AE Lobby Renovations Phase 2", dated 2/22/08:

- 2. Section 08 51 13.00 40, para 2.7 on page 276, "natural" shall be replaced with "black". (added item)
- 3. Section 01 45 00.00 40, para 1.3.2.1 on page 68, "sole" shall be removed from the first sentence. (added item)

2. Based on answers to questions, Clause L. 9 NFS 1852.223-73 SAFETY AND HEALTH PLAN (NOV 2004) (MODIFIED) has been updated to include ALT I (NOV 2004) which replaces the first sentence of (a) as follows:

"The apparent low bidder, upon request by the Contracting Officer, shall submit a detailed safety and occupational health plan (see NPR 8715.3, NASA Safety Manual, Appendices). C. Questions and Answers

1. Reference: <u>Drawing 79K38322</u>

Question: A fire suppression system is in process of installation but we do not see any plans for drops in the offices or under the stairs. Who is responsible for this work?

Answer: The contractor is not responsible for drops and sprinkler heads on flex piping for the three

offices and the space above them; contractor is responsible to adjust head locations to center of new ceiling tiles in offices (See Flag Note 7 on sheet 19 (M3) of Drawings 79K38322). Sidewall drops and sprinkler heads under the stairs are not in this project.

2. Reference: Drawing 79K38322, sheet 3 (C1)

Question: With reference to the tie-ins for the sanitary pipe for the new kitchens, how far from the building is the existing line? Is a drawing of the existing piping available?

Answer: See Drawing 701/28222 wheat 2 (C1) Flow Notes 1 through 7. This short contains all the

Answer: See Drawing 79K38322, sheet 3 (C1), Flag Notes 1 through 7. This sheet contains all the information necessary for your bid.

3. Reference: Solicitation NNK09274365E

Question: Can bids be either e-mailed or Fed-ex delivered?

Answer: Per Solicitation NNK09274365E, pages 51-52, L.11, KSC.52.214-90 Delivery Instructions for Bids/Proposals (Aug 2005) – (Modified), bids shall only be delivered or hand-delivered in accordance with (a) and (b) of the clause. No emailed or faxed bids will be accepted. If delivery via mail (FedEx, etc.) use the address in the clause.

4. Reference: Drawing 79K38322, Sheet 2 (V2)

Question: Has the floor tile, tile adhesive, insulation, and paint been tested for asbestos or lead? Answer: See Drawing 79K38322, sheet 2 (V2), "Environmental Notes". Asbestos is present as identified in sheet 2 under "Asbestos Schedule" and "Environmental Notes". The Asbestos survey report mentioned under Environmental Note 3 will only be made available to the contractor after award. Floor tile and adhesive are not positive for asbestos. Lead paint issues exist in the metal stair to be demolished and the steel frame openings to be modified.

5. Reference: <u>Drawing 79K38322</u>, Sheet 7 (A3), Note 1

Question: It may be difficult to match the existing ceiling/roof insulation that requires repair. Was the ceiling meant to be painted?

Answer: See Drawing 79K38322, sheet 7 (A3), Flag Note 7. No, the ceiling/ceiling liner is not to be painted.

6. Reference: Drawing 76K38322, Sheet 13 (S1), Flag Note 7

Question: The concrete slab for the covered porch appears to have some elevation concerns. The East end would appear to be above the existing asphalt if it is poured level. The slab will also have to be ADA accessible. Please review and advise.

Answer: The elevation difference of the asphalt at the east end is expected. The slab slopes in a northeasterly direction; pedestrian entry is along the north edge. Sheet 13 (S1), area G7 shows the slope drain and the entrance.

7. Reference: <u>Drawing 79K38322</u>, Sheet 12 (A8)

Question: The drawings call for the existing overhead doors to be removed and in-filled. Are we to insulate the in-filled areas? What type of insulation is required if necessary?

Answer: See Drawing 79K38322, sheet 12 (A8), Sections A and B. "6" BATT INSULATION" is

labeled.

8. Reference: Solicitation NNK09274365E, page 12

Question: Page 12 of the Solicitation states the work hours are M-F 7:00 to 3:30. Is this a strict requirement, or will we be permitted longer days and weekends? The restricted work hours are a real disadvantage to out-of-town contractors.

Answer: Per Clause F.2 Work Period, on page 12, "... Any other work period will require special/ written approval from the Contracting Officer seven (7) days in advance of proposed change in work periods." This would be worked out after contract award.

9. Reference: <u>Drawing 79K38322</u>, Sheet 11 (A7), Flag 14

Question: Sheet 11 (A7) of the plans, Flag 14 states four 60" plasma TV's are not in contract (NIC). Just wanted to be sure this is correct and the plasma TV's are not in the contract. Answer: Yes, plasma TV's are not in contract (NIC).

10. Reference: Cover Letter for Solicitation NNK09274365E

Question: In the cover letter it states "This acquisition is a set-aside for service-disabled veteranowned small businesses (SDVOSB)." How do I know if I qualify as a Service-Disabled Veteran-Owned Small Business (SDVOSB) for this project?

Answer: To qualify as an SDVOSB you must meet the SDVOSB requirements listed in FAR 19.1403 under the NAICS code for this acquisition, 236220, as referenced in Solicitation NNK09274365E, Section K, K.2 FAR 52.204-4 Annual Representations and Certifications (JAN 2006), (a) (1), page 42.

11. Reference: Solicitation NNK09274365E

Question: I have been unable to locate in the specifications the liquidated damages and the retainage (the percentage amount withheld until the project is complete) amount for this project. Please provide this information.

Answer: For this project there are no liquidated damages. The retainage amount for this project can be

found on page 11 of Solicitation NNK09274365E, Clause E.4 Final Inspection and Acceptance, Note: "...equal to 10% of the contract value or \$100,000, whichever is less."

12. Reference: <u>Drawing 79K38322</u>, Sheet 9 (A5)

Question: Can we get additional information on the furniture requirements listed in the furniture schedule on sheet 9 (A5) of the drawings (79K38322)?

Answer: Per Solicitation NNK09274365E, page 4, C.2 Contract Drawings, Maps and Specifications, under (b) of this clause, "4. Sheet 9 (A5), Furniture Schedule, is removed in their entireties and WILL NOT be bid upon in this solicitation."

13. Reference: Drawing 79K38322, Sheet 27 (E4)

Question: Sheet E-4 Lighting Fixture Schedule shows a type "F" fixture. Please identify location and quantity to install.

Answer: There are no "F" fixtures on the project. (See Paragraph B of this amendment)

14. Reference: RFP NNK09274365E, Section L, Para L.9 (a)

Question: The above referenced RFP paragraph states that the offeror shall submit a detailed safety and occupational health plan as part of its proposal. This plan was not listed in section L, para L.13 (d). Does NASA indeed want this plan with the proposal or submitted prior to award? Answer: Clause L.9 (a) on page 48 of Solicitation NNK09274365E is incorrect. It should include Alt I which replaces the first part of paragraph (a) as follows: The apparent low bidder, upon request by the Contracting Officer, shall submit a detailed safety and occupational health plan (see NPR 8715.3, NASA Safety Manual, Appendices). The plan shall be submitted within the time specified by the Contracting Officer. Failure to submit an acceptable plan shall make the bidder ineligible for the award of a contract." The safety and health plan will either be requested individually, or in conjunction with a pre-award survey (See Clause M.2 (f), p. 55). The safety plan must be approved prior to award of the contract. (See Paragraph B of this amendment)

- 15. Reference: Specification 79K38323, Section 01 30 00.00 para 1.4 and 01 45 00.00 40 para 1.3.2 Question: The above spec sections call for a QC Manager, that has no other duties, be on site at all times. The size (~1300 SF) and complexity (interior remodel) would seem to not warrant a person with only QC duties. Could a superintendent fulfill this role?

 Answer: Yes. (See Paragraph B of this amendment)
- 16. Reference: Specification 79K38323, Section 08 41 10 para 2.8 and 08 51 13.00 40 para 2.7 Question: Para 2.8 calls for aluminum finish of AA-M10-C22-A44, color "black". Para 2.7 calls for aluminum finish of AA-M12-C22-A41 which is for a clear natural Class 1 anodized finish but then goes on to define a "black" color. What finish does NASA want for the windows and storefront? Observation, NASA usually uses clear natural anodized finish.

 Answer: Aluminum finishes shall be black anodized. (See Paragraph B of this amendment)
- 17. Reference: <u>RFP attachment J.C.1</u>, para <u>J-C-7 and Spec11 31 13 and Drawing A7</u>, Sheet 11 of 28. Question: Attachment J.C.1 lists only the Ice Maker as GFE. Spec section 11 31 13 does not address any items as being GFE. Drawing A7 lists the Freezer, Refrigerator, Dishwasher and kitchen sink as GFE. Please confirm what items are GFE.

Answer: Only the ice maker is GFE. The freezer, refrigerator, dishwasher and kitchen sink are correct labeled as Contractor furnished items in Specification 79K38323, Section 11 31 13, pages 538 – 361. In Drawing 79K38322, Sheet A7 (11), Flag Notes 21 – 24 are amended to remove "GFE" reference. Also, in Drawing 79K38322, Sheet 21 (A-7), Plumbing Fixture Schedule, in the GFE column all shall

be changed to "N" except for IM-1, Ice Machine, which will remain "Y". (See Paragraph B of this amendment)

18. Reference: Drawing 79K38322, M3, Sheet 19 of 28

Question: Flag note 7 on drawing M3 states that we are to relocate sprinkler heads and piping as required for new ceiling. During the site visit it was observed that there are no existing sprinkler heads in the existing office area. Please clarify the desired scope of work in this area. Answer: M3 Flag note 7 is correct; sprinklers will be in place prior to this contract award.

19. Reference: <u>Drawing 79K38322, E4, Sheet 27 of 28</u>

Question: The lighting fixture schedule calls for a fixture marked "F". We can not find any "F" type fixtures. Please confirm there are no "F" fixtures on this project.

Answer: There are no "F" fixtures on the project. (See Paragraph B of this amendment)

20. Reference: Solicitation NNK09274365E, page 4

Question: On sheet 5 (A1) – Note 2 it states that flag note 8 is to be removed; however, there are no flag notes on the page, only demo notes. To what is this referring?

Answer: Reference Solicitation NNK09274365E, page 4, C.2 (b) under "<u>Drawing 79K38322, titled</u> "<u>Hangar AE Lobby Renovations Phase 2"</u>, dated 2/15/08:" Addenda (b) (2). Revise the word "Flag" Note to read "Demolition" Note. (See Paragraph B of this amendment)

21. Reference: Solicitation NNK09274365E, page 5

Question: Included on the Addendum Notes included with the Spec Book: it states that on the door schedule to eliminate fiberglass doors. On the door schedule doors 1100, 1103, 1104, and 1105 are Fiberglass. It appears that there is a necessity for these doors to exist and yet there is no replacement/substitution given for these doors. Should these doors be included and what is the substitution for the fiberglass??

Answer: Reference Solicitation NNK09274365E, pages 4 and 5, C.2 (b) under "<u>Drawing 79K38322</u>, <u>titled "Hangar AE Lobby Renovations Phase 2"</u>, dated 2/15/08:" Addenda (b) (5) and (6). The first addendum note, (b) (5), states "Sheet 10 (A-6), Door and Frame Flag Note 1, is removed in its entirety." This means that this specific flag note is removed from the drawing, not that all fiberglass doors are removed. Flag notes 1 and 3 were redundant; Flag note 3 remains, specifying fiberglass doors for Type "C". The second addendum note, (b) (6), states "Sheet 10 (A-6), Door and Frame Schedule, for Marks 1103 through 1105, the type is changed from a Type "D" to a Type "C"." This means that the type of door is "C" instead of "D". None of these addenda state that fiberglass doors should not be used for doors 1100, 1103, 1104, and 1105; provide the door material type as listed in the "notes" section of the "Door and Frame Schedule".

22. Reference: Specification 79K38323, Section 10 73 16

Question: Concerning the pre-engineered metal building – What is the manufacturer's name for the pre-engineered building?

Answer: The only pre-engineered structure being installed is the canopy; see Specification 79K38323, section 10 73 16, article 2.10, pages 352 - 357. There is no specific manufacturer; the canopy must meet the requirements in this section of the specification.

23. Reference: General information

Question: How many qualified (SDVOSB) vendors are bidding on this project and who are they?

Answer: The only available information we currently have is who attended the site visit which can be

found on FedBizOpps.gov and NAIS (http://prod.nais.nasa.gov/cgi-binieps/bizops.cgi?gr-,D&pin=76) which must be searched under the synopsis/reference number NNK09KRC1P for this solicitation. We will not know who or how many bidders we have until bid opening. A copy of the bid abstract will be available after bid opening.

24. Reference: Badges and security

Question: Are all material delivery vendors required to have a badge and or be checked in prior to entering the base? i.e. Concrete truck drivers, building material drivers etc.

Answer: All personnel will have to have badges in accordance with Clause I.9 KSC 52.204-96 SECURITY CONTROLS FOR KSC AND CCAFS.

Question: Are there any Special permitting/safety/Inspection requirements?

Answer: Section E of the solicitation identifies the general inspection requirements. Sections J-B and J-C address project specific permitting requirements.
