Dear Ms. Hardy:

This letter concerns Glaxo Wellcome Inc.'s (GW) promotional materials for Relenza. As part of its routine monitoring and surveillance program, the Division of Drug Marketing, Advertising, and Communications (DDMAC) has reviewed the TV broadcast advertisement for Relenza, "Home Again," submitted by GW under cover of Form FDA 2253 on November 11, 1999. From its review, DDMAC has concluded that GW has distributed materials that are false and/or misleading, in violation of the Federal Food, Drug, and Cosmetic Act and its implementing regulations.

Misleading Efficacy Presentation

The overall presentation in the advertisement is misleading because it suggests that Relenza is more effective than has been demonstrated by substantial evidence. Specifically, the images misleadingly suggest that Relenza has been shown to eliminate the flu more quickly and completely than has been demonstrated. According to the product labeling, results suggested up to one day of shortening of median time to improvement, not elimination, in major symptoms of influenza in patients receiving Relenza compared to those receiving placebo. The definition of time to improvement was no fever and self-assessment of "none" or "mild," meaning flu symptoms may still persist—to suggest otherwise is misleading. In fact, some fluctuation of symptoms was observed even after patients reached the defined time to improvement. Further, the statements, "... to help you start feeling better sooner" and "It may take a few days to see results," are neither sufficiently prominent nor adequate to overcome the impact of the misleading efficacy presentation.

GW should immediately discontinue the use of this broadcast advertisement and other promotional materials or activities that contain these or similar claims. GW should respond in writing no later than December 8, 1999, describing its plan to comply. GW should also include a list of materials being discontinued, as well as the date of discontinuation.

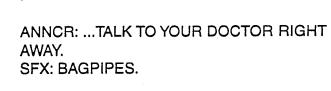
