Dear Ms. DeVenezia-Tobias:

As part of its routine monitoring and surveillance program, the Division of Drug Marketing, Advertising, and Communications (DDMAC) has become aware of a direct-to-consumer television broadcast advertisement for Xenical entitled "Baby On A Scale, Body Mass Index," disseminated by Hoffmann La Roche, Inc. This advertisement promotes Xenical in violation of the Federal Food, Drug, and Cosmetic Act (the Act) and its implementing regulations. Specifically, we object for the following reasons:

Reference to the Xenicare support program renders this broadcast advertisement a product-specific advertisement. Xenical is the only weight loss product with a support program named Xenicare.

Therefore, the advertisement is in violation of the Act and its implementing regulations because it identifies the specific product but does not contain information regarding Xenical's full indication or adequate provision for dissemination of the approved product labeling. Furthermore, the advertisement lacks fair balance.

In order to address these objections, we recommend that you take the following actions:

- 1. Immediately discontinue the use of this and all other similarly violative promotional materials.
- 2. Provide us with a statement, in writing, of your intent to comply with the above request. Your response should be received by April 13, 2001.
- 3. Include a list of all violative promotional materials and the method of their discontinuation with your response.
