98.	Are there any medical doctors who are civil servants who see patients?	NASA has a chief medical officer & physicians in the Aerospace Medicine and Occupational Health Branch that are civil servants, who see a limited number of patients. These patients are not associated with the care provided under MESC.
99.	How many employees in this MESC scope are unionized?	The current CBA information is posted on the MESC web site; however, the number of employees by job category will not be published.
100.	Is the lab equipment in each area owned by NASA?	Section J, Attachment J-6 of the DRFP includes listings of Government Furnished Property, as well as property currently owned by the incumbent contractor which will be made available for purchase (after inspection) to the successful offeror.
101.	How many square feet for each of the two fitness centers?	There will be an attachment to the final RFP identifying the approximate square footage for all of the facilities under the MESC. The O&C Fitness Center is approximately 7,500 square feet and the OSB Fitness Center is approximately 3,200 square feet.
102.	Is the occupational health facility for employees only or are families granted medical care at the facility?	Only badged employees may use the Occupational Health Facility, except in the case of an on-site emergency
103.	a. Who is responsible for travel budget for site visits?b. How many site visits and who pays their travel?	a. The offeror is responsible for proposing the travel budget as part of their RFP.b. Offerors are referred to Attachment J-5 for work load indicators.
104.	Are visitors treated at the clinic? If so, how is billing done or do they pay cash at the time of service?	Visitors will be treated at the Kennedy Space Center Visitors Center Nursing Station, or in event of emergency, in limited circumstances at the OHF. There is no charge to the patient for those services.

112.	What were the historical amounts awarded for the MESC effort in the current RFP?	The work to be performed under the MESC is comprised of efforts currently provided under three different contracts. The contracts are as follows: Joint Base Operations Support Contract (J-BOSC), NAS10-99001, Life Sciences Support Contract (LSSC), NAS10-02001, and the Specialized Physician Support for Human Spacecraft Launches and Landings contract (SPSHSLL) NAS10-02028. Of these three only NAS10-02028's scope is represented entirely in the MESC as PWS section 2. Only portions of the scope of J-BOSC and LSSC are in the MESC and the awarded amounts for each contract represent the entire scope of each current contract.
