Overview

Introduction

When discussing large case audit techniques, one usually thinks of examination or audit procedures. However, large case audit techniques include both administrative and audit procedures. An example of an administrative procedure would be a workpaper format, while a Form 4764B contains examples of audit procedures.

Large case audit techniques can be found in several sources, including the Internal Revenue Manual, the Employee Plans Team Audit (EPTA) Desk Guide, and large case audit procedure templates. The EPTA Desk Guide is a comprehensive guide that was prepared as part of the EPTA pilot program and is being shared with you for reference purposes.

Because the resource material is so inclusive, specific individual topics will not be repeated here with the exception of the large case audit procedure templates. The large case audit procedure templates have been included as exhibits because the procedures can be used on all cases involving large taxpayers, even if Form 4764B is not required.

EPTA Desk Guide

The desk guide created for EPTA has been included on the CPE2003 CD because it includes directions regarding large case audit techniques. The EPTA Desk Guide summarizes audit techniques that consist of both administrative and audit procedures.

Exhibit 1 indicates the EPTA Desk Guide discusses many topics that include preparation of an audit plan, specialist referrals, and workpapers. Generally, large case audit procedures are summarized on Form 4764B. The use of Form 4764B is explained starting on page 3 of Chapter 2 (Administrative Information) in the EPTA Desk Guide and is required in the EPTA pilot program.
