Welcome to the Bureau of Land Management's website for the **Final Vegetation Treatments Using Herbicides on Bureau of Land Management Lands in 17 Western States Programmatic Environmental Impact Statement (PEIS)**, and the **Final Vegetation Treatments Using Herbicides on Bureau of Land Management Lands in 17 Western States Programmatic Environmental Report (PER)**. The website contains the Final PEIS (3 volumes), Final PER (1 volume), Final Biological Assessment, and reports that describe the effects of all vegetation treatment methods on air quality and paleontological resources, and the human health and ecological risks associated with the use of herbicides. The reports, which were used to prepare the Final PEIS and PER, provide more detailed information than could be included in the Final PEIS and PER.

The website includes the Final PER and PEIS and their associated reports. For a quick overview, read the Abstract and Executive Summary in the PEIS, and Executive Summary in the PER.

Viewing the Final PEIS and PER on CD, Paper, or the Website

Whether you read the Final PEIS and PER on CD, the BLM website, or as a hard copy, you will find that all formats contain the same information. However, the presentation on the interactive sites may differ slightly from what you see on the hard copy version.

Viewing the Website

In order to view the files on the website, you will need the most recent version of Adobe® Reader®, or another software program that can read PDF files.
