Pacific Northwest Weekly Feed Summary (Excerpts) 09/16/08

Feed ingredient offers ended the reporting week on Tuesday, Sept. 16, mixed, mostly lower compared to last Tuesday's offers. Soybean meal, canola meal, barley and whole cottonseed offers were lower, while offers for corn trended mixed. Distillers dried grain and wheat millrun offers were steady to higher, while suncured alfalfa pellet offers were higher. Oats and meat and bone meal offers ended the reporting week steady with last Tuesday's offers.

Oilseed Meal Markets: Offers for 47% protein Soybean Meal, for current rail delivery, were 3.70 to 22.70 per ton lower at 343.50 to 412.50 per ton. Basis offers ranged from 23.00 to 92.00 per ton over the Chicago October soybean meal futures close of 320.50 compared to last Tuesday's basis range of 25.00 to 75.00 per ton over the Chicago September soybean meal futures close of 341.20. Offers for soybean meal truck delivered to the Willamette Valley were 415.50 to 427.50, 8.70 to 12.70 per ton lower than last Tuesday's offers. Offers for nearby delivered Canola Meal, 34 to 36% protein, rail delivered to points between Portland, Oregon and Chehalis, Washington, were 200.50 to 215.50, 24.70 to 28.70 per ton lower compared to last Tuesday's range. Offers for canola meal trans-loaded onto trucks and delivered to the Willamette Valley were 23.70 to 24.70 per ton lower at 220.50 to 235.50. Canola Meal offers for truck delivery to points east of the Cascades were 218.50 to 240.50, 20.70 to 25.70 per ton lower than week ago offers.

Whole Cottonseed: Offers for delivery to points in the Pacific Northwest from the Midsouth in single boxcars were 15.00 to 30.00 per ton lower at 410.00 to 435.00. Offers for whole cottonseed trans-loaded onto trucks and delivered to Willamette Valley dairies were also 15.00 to 30.00 per ton lower at 427.00 to 455.00.

Animal Proteins: Offers for 46 to 50% protein Meat and Bone Meal, FOB Seattle plants, were steady at 365.00. Offers for meat and bone meal truck delivered to Portland and the Willamette Valley were also steady at 390.00.

Wheat Millrun: Feed mill offers for wheat millrun for nearby delivery, loaded truck FOB the flour mill in Portland, were indicated as steady to 3.00 higher, from 185.00 to 195.00. Offers for wheat millrun truck delivered to the Willamette Valley were also steady to 3.00 higher, ranging from 202.00 to 205.00. Flour mill offers for wheat millrun rail delivered on the Burlington Northern Line to Portland from eastern Washington and eastern Oregon during August through December were not available. Offers for wheat millrun FOB eastern Oregon and eastern Washington mills for Sept. to March delivery were indicated as 155.00.

Alfalfa Products: Offers for Suncured alfalfa pellets, 15% protein, delivered by truck to the Willamette Valley, were 295.00 per ton, 5.00 to 10.00 per ton higher than last Tuesday's offers.

Distillers Dried Grains: Offers delivered by rail to feed mills in the Pacific Northwest were 4.00 to 15.00 per ton higher at 175.00 to 183.00. Offers for distillers dried grains trans-loaded onto trucks and delivered to Willamette Valley dairies were steady to 20.00 per ton higher at 195.00.

Coarse Feeding Grains: Offers for US 2 Barley for nearby delivery to Portland in single rail cars for domestic use were not well tested but were indicated as 5.00 to 23.00 per ton lower at 200.00 to 225.00. Offers for US 2 Barley rail and truck delivered to the Willamette Valley were also not well tested but were indicated as 215.00 to 235.00, 20.00 per ton lower than week ago offers. Some barley traders were not issuing offers for nearby delivery. US 2 Yellow Corn offers for rail delivery to points north of Seattle were 4.50 per ton lower at 239.00 to 242.50. Offers for US 2 Yellow Corn rail delivered to points in the Seattle area were 4.25 per ton lower at 235.50 to 240.50. Offers for US 2 Yellow Corn rail delivered to Portland were 234.25 to 238.25. 50 cents to 4.50 per ton lower compared to week ago offers. Offers for US 2 Yellow Corn truck delivered to the Willamette Valley trended mixed, from 4.50 lower to 2.75 per ton higher, ranging from 249.00 to 265.00. US 2 Yellow Corn offers for truck delivery to the Yakima Valley were 230.00 to 238.25, 75 cents to 4.50 per ton lower. Offers for US 2 Yellow Corn rail delivered to the Yakima Valley were not well tested. Lower Chicago December September corn futures, at 5.32-1/4 compared to last Tuesday's December close of 5.44-1/2, pressured cash corn offers. Offers for US 2 Heavy White Oats were indicated in a very limited test at 220.00 to 225.00, steady with last Tuesday's offers.

Cheddar Cheese prices received for US 40 pound Blocks averaged \$1.72 per pound for the week ending September 13. The price per pound decreased 1.8 cents from the previous week. The price for US 500 pound Barrels adjusted to 38 percent moisture averaged \$1.71 per pound, up 1.9 cents from the previous week.

Butter prices received for 25 kilogram and 68 pound boxes meeting USDA Grade AA standards averaged \$1.61 per pound for the week ending September 13. The U.S. price per pound increased 0.5 cents from the previous week.

Nonfat Dry Milk prices received for bag, tote and tanker sales meeting USDA Extra Grade or USPH Grade A standards averaged \$1.21 per pound for the week ending September 13. The U.S. price per pound decreased 11.4 cents from the previous week.

BUTTER- WEST 09/17/08

Cash butter prices at the CME Group had held at \$1.66 for seven trading sessions. Prices have been above \$1.60 since August 4. This

week, prices increased 4 cents to \$1.70 at midweek. Prices have not been this high since September 2005. Buyers are looking to cover their fall needs at this time. Cream supplies are somewhat heavier and churns are very willing to take the extra cream to churn additional butter. Most contacts expect this to be a good fall for butter sales activity. July butter output, according to NASS, was 116.6 million pounds. That is the most butter produced in July since 1962. This week, CME butter stocks in approved warehouses were 73.5 million

pounds, moving 4.9 million pounds lower from the prior week. This compares to 132.3 million pounds a year ago and 105.8 million pounds for the same week in 2006. In the last 10 weeks, stocks have declined 34.6 million pounds. Last year for the same period, stocks fell 14.9 million pounds and they fell 51.0 million pounds in 2006. Prices for bulk butter range from 2 cents over the market to 4 cents under the market, based on the CME with various time frames and averages.

Block cheese prices at the CME Group touched \$1.90 again last week. Prices have not been this high since July 30. There has not been a trading session with lower prices since September 2. Prices gained another 3 cents this week to stand at \$1.9225. Most of the upward movement has been on bids with few sales. The downward movement prior to that time had much more sales activity. Buyers have stocked up heavily on this last dip in prices. Basically barrels, blocks, and under grade cheese are all clearing very well. The normally good fall demand season was another factor in additional purchases. Buyers had started the fall with lower than normal stocks, but they are now building inventory for fall needs. Sales of mozzarella are fair for some accounts and strong for others since schools and colleges have started their fall classes. Swiss stocks are in very good shape as fall approaches. They are at a lower level than 3 out of the past 4 years. Cheese production is on the heavy side of expectations.

FLUID MILK & CREAM REVIEW - WEST 09/18/08

CALIFORNIA milk output is mostly steady to occasionally higher. Weather conditions have been moderate and allowing for better



comfort levels, but milk levels are not changing. Currently, processors are running on somewhat reduced schedules and planning down days to take care of maintenance issues. There are reports that more cows will be freshening in October, as well as more heifers calving. This could impart more milk onto processors. Media reports indicate that several producers are soon to be without a processing outlet, as their current processor is not renewing their contracts. As other processors have base plans and

production limits on their current producers, finding another processing home could be challenging at this time. Milk production in ARIZONA is holding flat at the seasonal low level. Fat and protein levels are also remaining on the low side. Temperature and humidity have been lower, but there has been limited response from the milking herds. Processing plants are running abbreviated schedules because of the local milk situation and due to little available milk being offered from nearby states. Bottlers are pulling steady milk volumes. NEW MEXICO milk flow from farms is steady to trending higher. Generally, conditions are improving seasonally. Milk handling was challenging over the past week because of the hurricane hitting Texas. Bottlers in the path were often without power and had limited needs because of either storm or power issues. Transportation issues for milk shipments to the Southeast states were also more complicated through the storm. CREAM markets are mainly steady. Supplies are in fair to good shape with surplus loads readily balanced. Multiples have moved lower as butter prices and averages have increased. Demand for cream is good from butter churners, but at seasonal, limited levels from higher class product accounts. The CME Grade AA butter price closed at \$1.70 on Wednesday, September 17, up 4 cents from a week earlier. Multiples range from 108-128 and vary depending on class usage and basing points. Conditions have finally warmed up in September in the PACIFIC NORTHWEST. The crops need the heat to try and still reach maturity. Corn for silage is still guite immature in much of the region after a very cool August. If the fall weather is good, there is still the possibility that the corn silage crop will produce a good feed supply. If the fall weather does not cooperate, it will mean lower feed quality and either less milk or more cost to do supplemental feeding. A number of contacts also mentioned that cannery waste supplies seem to be down 20-30% from last year. This will further stress dairies financially. Some are looking at doing more with grass hay. Regular alfalfa hay remains expensive and in tight supply. Plants in the region are operating efficiently with current supplies of milk. Farm level milk supplies are declining and tests are lower because of very expensive feed supplements, especially cottonseed. Milk supplies in UTAH and IDAHO are at expected fall levels. Some plants are bringing in some outside milk to supplement their own supplies to more closely balance out their production needs. Cheese plants in the region are noting good demand on this latest price run up cycle. Buyers need cheese for fall programs and the recent lower prices were a good stimulus to move more cheese.
