## ATTACHMENT B.1 - SECTION B.2.1 PRICE TABLES/LOTS

**B.2.1 Price Tables/Lots** The tables provided are samples to be used by the Contractors to prepare new contract line item proposals. The Contractor must provide price tables that contain the columns described below for Lots 1-5 and, as applicable, for Lot 6. All of the items or services offered, for which the Contractors expect to receive compensation (i.e., payment), must appear in these price tables. If there is no explicit charge associated with a particular item or service, "N/C" (i.e., No Charge) shall be noted in the Product Description column and zero placed in the price column. If an item is associated with one or more ELAs, the number of ELAs it is associated with must be clearly indicated on the price table and the ELA ID Number, Title, and Manufacturer for each ELA entered into an ELA Form (Attachment Number JA.1 contains the ELA Form and specific instructions). The ELA Form shall be attached to the price table along with a copy of each ELA. A separate unit price table is used to describe the COTS products and related support services offered for each Lot. The information required for each column of the price tables for Lots 1-5 is defined below in Section B.2.1.2. The information required for each column of the price table for Lot 6 is defined in Section B.2.1.3.

#### B.2.1.2 Header and Column Descriptions for Tables Specific to Lots 1 through 5:

Header NITAAC Proposal Number. In the table header, the Contractor shall enter the ECS III Vendor Name, Contract Number, and the NITAAC proposal number. The NITAAC proposal number should contain the prefix, which has been assigned to its company by the NITAAC Contracting Officer (CO), followed by a dash and a four digit proposal sequence number. The list of NITAAC Proposal Number Prefixes assigned to each Contractor is located in Attachment JA.2 of this contract document. The prefix consists of a three letter abbreviation of the Contractor's name followed by the last three numbers of the contract number. For example, a company named "Welcome Back Limited", with a contract number of "263-03-D-0342", might have the assigned prefix of "WBL342" and would submit modification proposals with the NITAAC Proposal Numbers: WBL342-0001, WBL342-0002, WBL342-0003, etc. Contractors may also include their own proposal tracking number as a suffix to the NITAAC Proposal Number (e.g. WBL342-0001-cmod14001).

<u>Column 1 – Lot</u>. In this column, the Contractor shall enter the Lot number for the product being proposed. (A single Lot 1 - 5 price table can be submitted for all Lot 1 through 5 products being proposed.)

<u>Column 3 - Original Equipment Manufacturer (OEM) Name</u>. In this column, the Contractor shall identify the name of the Original Equipment Manufacturer (OEM) for the CLIN.

<u>Column 4 – OEM Model Number (Optional)</u>. Enter the specific equipment model numbers for all equipment components for the CLIN. For example, manufacturer server model "3000" series, where "3000" is the model number.

<u>Column 5 – OEM Part Number/Identification Number</u>. Enter the specific equipment make part numbers for all equipment components for the CLIN. For example, Q5420BB. This number allows the NITAAC Contracting Officer to track the commercial availability and pricing of the Lot 1-5 CLIN.

<u>Column 6 – Contractor Identification Number (Optional)</u>. If desired, enter the specific equipment identification number used for Contractor tracking of the product.

Column 7 – Product Description. Enter a brief, but clear, description of the IT resource and salient characteristics for each item listed in the price tables. For example, you might describe a laptop in terms of "Lightweight, Pentium III laptop with Windows XP Operating System, and carrying case". Avoid technical abbreviations and jargon by using common language whenever possible. If volume discounts are offered, also enter the quantity range that is applicable for the offered price i.e. (1 - 10), (11 - 20). Each price break must be listed under a separate Contract Line Item Number. If detailed information is provided in the next column (Technical Industry Specifications (TIS)), a general product description is sufficient here, such as "Laptop."

Column 8 – Technical Industry Specifications (TIS). List the technical specifications for the product, a TIS website Uniform Resource Locator (URL) where TIS specification information can be located, or "See Attached copy of Catalog Item". The following is an example of TIS: Pentium M 1.4GHz, 14.0" XGA, 256MB SDRAM, 40GB, DVD, V.90/56K Modem, 10/100 Ethernet LAN, Wi-Fi, USB FDD, 9 cell battery, Win XP Pro.

<u>Column 9 – Unit</u>. Specify the unit of items for which the ECS III price is based. For example, each, roll, box, case, etc. Most items will have a unit of "each."

<u>Column 10 – Quantity</u>. Specify the quantity of items for which the ECS III price is based. If the price offered is based upon a quantity of one (1) enter (1).

<u>Column 11 - Electronic Commodities Store III Price</u>. Enter the Electronic Commodities Store price proposed for each IT Resource included in the price tables.

<u>Column 12 - General Services Administration (GSA) Contract Number</u>. This column applies only if the product is on a GSA schedule. This includes schedule contracts with the OEM and Schedule contracts with the Contractor. Enter the GSA schedule contract number for all equipment and components included in the price tables.

<u>Column 13 - General Services Administration (GSA) Schedule Price</u>. This column applies only if the product is on a GSA schedule. This includes schedule contracts with the OEM and Schedule contracts with the Contractor. Enter the GSA price for all equipment and components included in the price tables.



Column 14 - Catalog/List Price. Enter the price for the product that would be offered to the general public. (See FAR 2.101 "Commercial Item" (6)(i).) This is the contractor catalog price or manufacturer's list price for the CLIN.

Column 16 -Number of Associated ELAs. If the CLIN is associated with one or more ELAs, the Contractor shall enter the number of ELAs in this column. In addition, the Contractor must attach a completed ELA Form to the price table. (See Attachment Number JA.1 for ELA Form instructions.)

Column 17 - EPEAT Compliant (Optional). If the item is EPEAT compliant, the Contractor may enter the level of EPEAT qualification (Silver, Bronze, Gold) in this column.

### **B.2.1.3 Header and Column Descriptions for the Table Specific to Lot 6:**

Header NITAAC Proposal Number. In the table header, the Contractor shall enter the ECS III Vendor Name, Contract Number, and the NITAAC proposal number. The NITAAC proposal number should contain the prefix, which has been assigned to its company by the NITAAC Contracting Officer (CO), followed by a dash and a four digit proposal sequence number. The list of NITAAC Proposal Number Prefixes assigned to each Contractor is located in Attachment JA.2 of this contract document. The prefix consists of a three letter abbreviation of the Contractor's name followed by the last three numbers of the contract number. Column 1 – Lot. In this column, the Contractor shall enter the Lot number for the product being proposed, "6."

Column 2 - CLIN. In this column, the Contractor shall list the Contract Line Item Number for the Lot 6 Item. Each CLIN must be unique across the entire contract.

Column 3 – Related Lot 1 - 5 NITAAC Proposal Number. If the related Lot 1 - 5 CLIN(s) was approved on a previous proposal, the Contractor shall enter the NITAAC proposal number(s) of the Lot 1 – 5 item(s) that this Lot 6 CLIN will support. If the related Lot 1 – 5 CLIN(s) are part of the current proposal submission, this column should be left blank. See the Header description above for a full description of the NITAAC Proposal Number. (If the Lot 1 - 5 CLIN being supported was proposed before Master Modification 2 of the ECS III contract and has not been updated since, the Contractor should enter any proposal identifier that may help the NITAAC CO locate the original Lot 1 – 5 item information.)

Column 4 - REQUIRED: Attach Adequate Work Description of Related Services. In this column, the Contractor shall provide a description of how the Lot 6 services will support, or relate to, the Lot 1-5 CLINs. The Lot 1 – 5 CLINs being supported must be identified. For example: CLIN 600487 is directly related to Lot 1E CLINs 100485 - 100487. The Lot 6 CLIN 600487 is for the installation of the Lot 1E software on 70 desktop computers.

Column 5 - OEM Name. In this column, the Contractor shall identify the manufacturer of the Lot 6 CLIN.



Column 6 - OEM Product Number/Identifier. In this column, the Contractor shall list the OEM product number/identifier to enable the NITAAC Contracting Officer to track the commerciality and pricing of the Lot 6 CLIN. For example, Q5420BB.

Column 7 - Product Description. In this column, the Contractor shall provide a short description of the Lot 6 CLIN being offered in the price table or put "See Attached" and provide a copy of the catalog item. For example, "Upgrade desktop computer Operating System from Windows 98 to Windows XP". Avoid technical abbreviations and jargon by using common language whenever possible.

Column 8 - Unit. Specify the unit of items for which the ECS III price is based. Most items will have a unit of "each."

Column 9 – Quantity. Specify the quantity of items for which the ECS III price is based.

Column 10 – ECS Price. In this column, the Contractor shall list the price of the Lot 6 CLIN as it is being offered under the ECS III contract.

Column 12 - General Services Administration (GSA) Contract Number. This column applies only if the product is on a GSA schedule. This includes schedule contracts with the OEM and Schedule contracts with the Contractor. Enter the GSA schedule contract number for all equipment and components included in the price tables.

Column 13 - General Services Administration (GSA) Schedule Price. This column applies only if the product is on a GSA schedule. This includes schedule contracts with the OEM and Schedule contracts with the Contractor. Enter the GSA price for all equipment and components included in the price tables.

Column 14 - Catalog List Price. Enter the contractor catalog or manufacturer's list price for the Lot 6 support service.

#### **B.2.2 RESERVED**

B.3 Program Ceiling Amount The program ceiling amount established for this acquisition is \$600 million a year for ten years, a period of one hundred twenty (120) months. The following provisions apply. The minimum contract amount established for this acquisition is \$100.00. Maximum contract amounts will not be established for individual contracts; however, the aggregate amount expended under all of the contracts awarded shall not exceed \$6,000,000,000.00 during a one hundred twenty (120) month period.
