## NPDB-HIPDB Internet Privacy Policy

	<p>The privacy of our customers has always been of utmost importance to the Data Banks. As a Federal agency, the <i>Privacy Act of 1974</i> (5 U.S.C. 552a) requires us to protect certain information we collect from you. Specifically, if we collect information from you that will be placed in the National Practitioner Data Bank (NPDB) or the Healthcare Integrity and Protection Data Bank (HIPDB), we will provide a separate <i>Privacy Act</i> notice at the point of collection, identifying (1) the legal authority which authorizes the collection; (2) whether the disclosure of the information is mandatory or voluntary; (3) the principal purpose(s) for the information; (4) the routine uses of the information; and (5) the effects on you, if any, of not providing the requested information. The <i>Federal Register</i> notices, which describe the <i>Privacy Act</i> aspects of the NPDB and the HIPDB, can be found at 62 Fed. Reg. 12653 (1997) and 64 Fed. Reg. 7653 (1999), respectively. The privacy policy information below applies to the data we collect from you over the internet, regardless of whether it is also protected by the <i>Privacy Act</i>.</p> <p>This is our notice to you about what personal information we collect; why we collect your personal information; how we use it; who we share it with; how to get access to your information; and how we protect the information we collect and maintain.</p>
<b>Information Automatically Collected and Stored</b>	<ul style="list-style-type: none"><li>• The date and time of your visit.</li><li>• The Web site pages you visited.</li><li>• The IP address and screen resolution of the computer you used when you visited our site.</li></ul>
<b>What Personal Information We Collect</b>	<p>We only collect enough information to serve the mission of the Data Banks. We collect the following personal information on subjects of NPDB and HIPDB reports and queries.</p> <ul style="list-style-type: none"><li>• Name.</li><li>• Date of Birth.</li><li>• Social Security Number.</li><li>• Mailing Addresses.</li><li>• Phone Numbers.</li><li>• E-mail Addresses.</li><li>• Education Records.</li></ul>

<b>Why We Collect Your Personal Information</b>	<ul style="list-style-type: none"><li>• Information is vital to the existence of the Data Banks. Without collecting the information contained in the Data Banks our mission could not be fulfilled. This information facilitates the tenets of our mission, including protecting the public and providing quality health care.</li><li>• We do not use the information for any other purpose.</li><li>• We only collect the information necessary to fulfill our mission. No other information is collected.</li></ul>
<b>How We Will Use Your Personal Information</b>	<ul style="list-style-type: none"><li>• The personal information you give us at this Web site will be used only in connection with the administration and execution of the Data Banks mission of protecting the public and providing quality health care.</li></ul>
<b>Who We Will Share Your Personal Information With</b>	<ul style="list-style-type: none"><li>• Personal information is only provided to registered entities with Federal authority to query the Data Bank(s). Information is not shared with any other non-registered third-party entities with the exception of plaintiffs' attorneys. If a practitioner is reported, a Subject Notification Document (SND) will be mailed to the practitioner.</li><li>• A plaintiff's attorney or a plaintiff representing himself or herself is permitted to obtain information from the NPDB under special circumstances. Defense attorneys are not permitted access to the NPDB under law. However, the defendant practitioner may self-query the NPDB. <b>Your Access to the Information We Collect About You</b>	<ul style="list-style-type: none"><li>• NPDB and HIPDB information is not available to the general public. However, persons or entities may request information in a form that does not identify any particular entity or practitioner.</li><li>• The information from the NPDB is available to State licensing boards; hospitals and other health care entities; professional societies; certain Federal agencies; and others as specified in the law to provide information on the professional competence and conduct of physicians, dentists, and, in some cases, other health care practitioners. Hospitals are the only health care entities with mandatory requirements for querying the NPDB. Practitioners may self-query the NPDB regarding themselves at any time.</li><li>• Federal and State government agencies and health plans are eligible to query the HIPDB. Health care practitioners, providers, and suppliers may self-query the HIPDB.</li><li>• Additionally, a plaintiff's attorney or a plaintiff representing himself or herself is permitted to obtain information from the NPDB under special circumstances. Defense attorneys are not permitted access to the NPDB under law. However, the defendant practitioner may self-query the NPDB. <b>How We Protect the Security of the Information We Collect</b>	<ul style="list-style-type: none"><li>• The internet was originally designed as an open system with no built in security; however, we are required to protect the information we collect and maintain about you and will not use the internet to do business with you unless we can do so in a secure manner.</li><li>• We have extensive security controls that are tested and reviewed continually.</li><li>• We are certified and accredited by Health Resources and Services Administration (HRSA).</li></ul>

<b>Our Concern About Sending Personal Information Via E-mail</b>	<ul style="list-style-type: none"><li>• Electronic mail is not secure. Therefore, we suggest that you do not send personal information to us via e-mail. We will only send you general information via e-mail.</li></ul>
<b>Our Use of “Cookies” and How It Affects Your Visit to Our Web site</b>	<ul style="list-style-type: none"><li>• What is a "cookie"? A cookie is a small piece of text that is sent to your computer along with a Web page when you visit a Web site. Your computer will give the information in the cookie only to the computer that sent it, and no other Web site can request it.</li><li>• The Data Banks do not use cookies.</li></ul>
<b>If You Visit Other Web sites</b>	<p>Our Web site contains links to commercial and Federal entities' Web sites. These Web sites are not within our control and may not follow the same privacy, security or accessibility policies. Once you link to another site you are subject to the policies of that site. However, all Federal Web sites are subject to the same Federal privacy, security or accessibility mandates as ours.</p>
