

# Patient Safety and Health IT Related Programs

- FY 2008 \$329.5 million request includes \$93.934 million for PS & Health IT(+\$9.934 million over FY 2007 CR)
  - Health IT = \$44.8 million
    - \$3.4 million in new Health IT grants
  - -General PS = \$49.114 (+ \$15M)
    - \$15 million for the Secretary's Personalized Healthcare Initiative


