If you have any questions in completing this return you may call us toll free at (866) 859-2254 (in Helena, 444-6900) or you may download detailed instructions for Form WET from our web site at www.mt.gov/revenue.

General Instructions

Please note that these general instructions do not provide detailed instructions for all lines. Some pre-populated lines and mathematical calculation lines require no further instructions than those provided on the actual tax return.

- Line 1 Enter your federal employer identification number (FEIN) on line 1.
- Line 2 Enter your Department of Revenue account number.
- Line 3 Enter your reporting period and filing due date. Your return is due 30 days after the end of the quarter. Use this form only to report your wholesale energy transaction tax for the period ending entered on line 3. If you are filing an amended return or a return for another period please use a separate WET form with the period ending that is being amended identified on line 3.
- Line 4 If you are amending a prior-period return, check the box on line 4. Do not use a return that includes pre-populated data. Please download Form WET from our website at www.mt.gov/revenue to complete an amended return.
- Line 5 If you are no longer in business and are filing a final return, check the box on line 5 and enter the date that your business ceased operations.
- Line 6 If your address has changed from the last report filed, check the box on line 6 and print your new address in the space provided.

Tax computation instructions (See instructions for the mathematical calculation lines on page 1 of this return.)

- Line 7 Enter your total amount of kilowatt hours produced in Montana and delivered into Montana during this quarter.
- Line 8 Enter your total amount of kilowatt hours produced outside of Montana and delivered into Montana during this quarter.
- Line 11 Enter the total amount of kilowatt hours produced in Montana that is delivered outside of Montana during this quarter.
- Line 12 You are allowed an allowance for transmission line loss for electricity delivered outside of Montana. This amount reduces your total kilowatt hours that are subject to the wholesale energy transaction tax.
- Line 15 Enter your credit for taxes paid to another state on the transmission of electricity.

When signing the return, provide your title and a telephone number where we can contact you if it is necessary.

When making your payment, please reference your account identification number located on line 2 of the return in the memo line of your check.
