## South Coast Air Quality Management District Deposition Plate Studies

Late in 2007, the AQMD completed data analysis for the MATES-III study, a regional evaluation of air toxics pollution in Southern California. Results indicated a noticeable upward trend of hexavalent chromium at the Western Riverside Air Monitoring Station relative to a previous air toxics study in 1998. This finding was contrary to anticipated levels, as several AQMD regulations should have resulted in a decrease of chrome 6 emissions.

AQMD staff investigated the reasons for the increase which included numerous activities related to air sampling, permit reviews, area-wide surveys and surveillance, air quality modeling, material and soil sample collection, and detailed chemical analysis. One type of sample that was collected were fallout or deposition samples. These samples were collected over three phases on glass plates that were exposed to the air for 4 to 7 days. The samples for which results are given below covered a wide geographic area in an effort to determine potential concentration gradients and thereby identify areas where sources of chrome 6 may exist. Results are shown in parts per billion and may also be expressed as nanongram per gram (ng/g); a nanogram is one billionth of a gram.

Caution needs to be taken in interpreting these results. Fallout or deposition sample results are not useable to determine the concentration of hexavalent chromium in ambient air. Thus these types of samples are not necessarily indicative of exposure. They are useful in providing an indication of geographic variations and in focusing on areas to search for sources of Hexavalent Chromium.
