Our review of the Calvert Cliffs Unit 1 First Quarter 2000 Performance Summary identified that the White threshold had been crossed for the Initiating Events Performance Indicator "Scrams With Loss of Normal Heat Removal." In accordance with NRC Inspection Manual Chapter 0305, Operating Reactor Assessment Program, Exhibit 5 - Action Matrix, we plan to conduct an additional (supplemental) inspection to better understand the cause(s) contributing to this performance trend.

This letter is to inform you that we are planning a supplemental inspection at your facility during the month of September 2000 to review your evaluation and the corrective actions for this White Performance Indicator.
