SUBJECT: MID-CYCLE PERFORMANCE REVIEW AND INSPECTION PLAN -

PEACH BOTTOM ATOMIC POWER STATION UNITS 2 and 3

Dear Mr. Skolds:

On July 31, 2003, the NRC staff completed its mid-cycle plant performance review of the Peach Bottom Atomic Power Station Units 2 and 3. The mid-cycle review for Peach Bottom involved the participation of all technical divisions in evaluating performance for the first half of the calendar year 2003 assessment cycle. The process included a review of performance indicators (PIs) for the most recent quarter and inspection results over the previous twelve months. The purpose of this letter is to inform you of our assessment of your safety performance and our plans for future inspections at your facility so that you will have an opportunity to prepare for these inspections and to inform us of any planned inspections that may conflict with your plant activities.

Plant performance for the most recent quarter was within the Regulatory Response column of the NRC's Action Matrix based on one safety significant inspection finding involving both units. The finding was of low to moderate safety significance (White) in the Emergency Preparedness cornerstone and involved improper use of Peach Bottom's emergency classification scheme during an Alert declaration in June 2002. We conducted a supplemental inspection for this finding in June 2003 and determined that Exelon's response was acceptable. Therefore, we plan to conduct only baseline inspections and other routine inspections at your facility through September 30, 2004.

The significance of a finding involving the loss of power to the Unit 3 high pressure coolant injection alternative control station for approximately nine days in May 2003, is still under review as part of the Significance Determination Process. The significance of this finding has the potential to be greater than very low safety significance, but does not present an immediate safety concern since Exelon has restored power to the control station. If the final significance of the finding is determined to be greater than very low safety significance, then we will inform Exelon of any changes to Unit 3's plant performance assessment and future inspection activities.

The enclosed inspection plan details the inspections scheduled through September 30, 2004. Our inspection plan also includes an inspection of your independent spent fuel storage installation in May 2004. The inspection plan is provided to minimize the resource impact on your staff and to allow for scheduling conflicts and personnel availability to be resolved in advance of inspector arrival onsite. Routine resident inspections are not listed due to their ongoing and continuous nature. The inspections in the last six months of the inspection plan are tentative and may be revised at the end-of-cycle review meeting.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be made available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS). ADAMS is accessible from the NRC Web site at http://www.nrc.gov/reading-rm/adams.html (the Public Electronic Reading Room).
