## Law of Gravity Not Repealed

ARLINGTON, Virginia - In a surprise announcement today, Robert M. Friend, Administrator for Metal and Nonmetal, announced that, "Congress has not repealed the Law of Gravity. If something is hanging over your head, it will still fall on you unless properly supported. You can also fall if not properly supported."

Mr. Friend is urging all mine operators and contractors to reinforce to all miners the hazards involved when trying to work against the Law of Gravity. "Too many miners are being hurt when things they are working on fall on them." said Friend. "Twenty-three miners were killed in the past two years alone by falling rocks or other objects. Everything from rocks, crusher liners, tires and even a

metal frame that was being fabricated in a shop have caused fatal injuries. We are asking all mine operators and contractors to remember that the Law of Gravity is still in effect and what is up definitely wants to fall down."



## Fatal Accidents On the Rise

ARLINGTON, Virginia - Accident Investigations Chief John Radomsky today announced that fatal accidents in the metal and nonmetal mining industry are on the rise. "Although fatal accidents hit an all time low during 2003, we have had five in just the past two weeks. The entire industry really worked hard last year and made a tremendous effort to reduce fatal accidents. Each and every one of them should be commended for a job well done," said Radomsky, "but now is the time to redouble

our efforts to build on last year's success. Although 2003 was a record year, it is still tragic that 26 miners lost their lives while at work, but it will be even more tragic if another 26, or even more,

lose their lives during 2004. That leaves a whole lot of people out there to suffer the loss of a loved one. There is still much more we can and must do in 2004. Our goal is always zero fatalities and perhaps someday, with industry involvement, we will get there."
