


Overweight in Chicago Public Schools Students (At Kindergarten Entry)




Prevalence of Overweight in Children




The CLOCC Model: Founding Principles

A strategic approach is also needed



Adiposity Rebound and Obesity



CLOCC's Early Accomplishments

Remarkable Growth

- From 80 to >900 in 2 years!
- Many from non-traditional health sectors
 - e.g., Food Depositories, Urban planners, Industry, etc

Active Network

- Quarterly Meetings now capped at 200 attendees
- Last QM March 3rd with a research focus
- Workgroups with specific projects
- Many unexpected networking results

Research

- Over \$200K in seed grant awards and WG projects to date
- TASK project foundational research
- CLOCC/CPS Study with follow-up project in Archdiocese
- Accelerometer Library now up and running
- Adding value to partners' work

Early Accomplishments (Cont.)

- Advocacy and Policy
 - 27 news placements in 24 h post release of CPS data
 - Total Broadcast and Print Reach estimated at 17M
 - Wrote IL SB 2940-signed into law 8/04
 - Similar, but different, than AR 1220
 - Led the development of the "Consensus Agenda"
 - 4 Bills passed through the IL Legislature in 2005
- Resource Development
 - Website, Listservs
 - Fact sheets, Annual Report
 - Manual for Primary Care
 - Publications
 - Newsletter, January 04 issue of Pediatric Annals
 - Workshops



Uptown	Cross too many streets	61.9%	Traffic too dangerous	57.1%
Ashburn	Traffic too dangerous	66.7%	Kids cross too many streets	44.4%
West Town	Gangs in neighborhood	94.7%	Traffic too dangerous	42.1%
W Garfield Pk	Gangs in neighborhood	77.3%	Traffic too dangerous	54.5%
