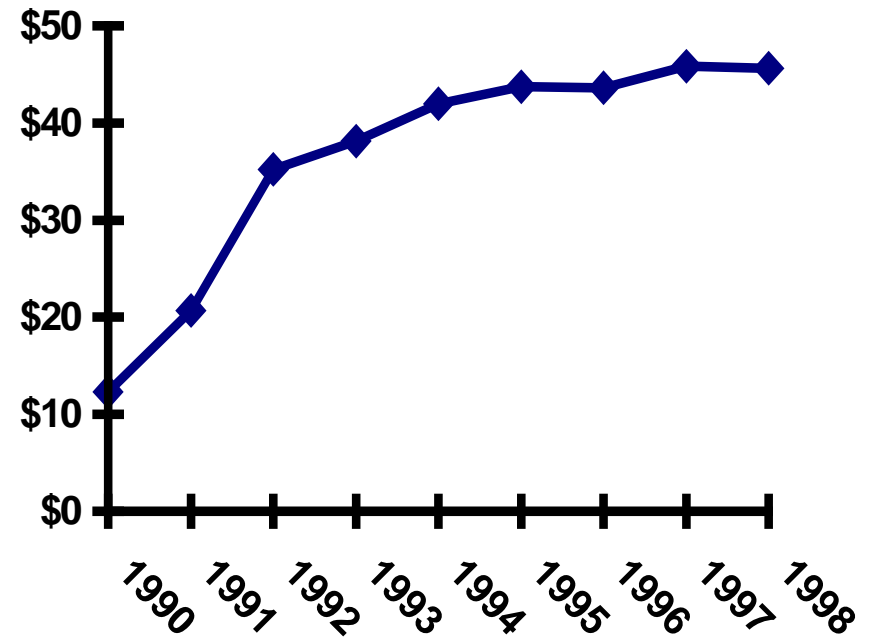

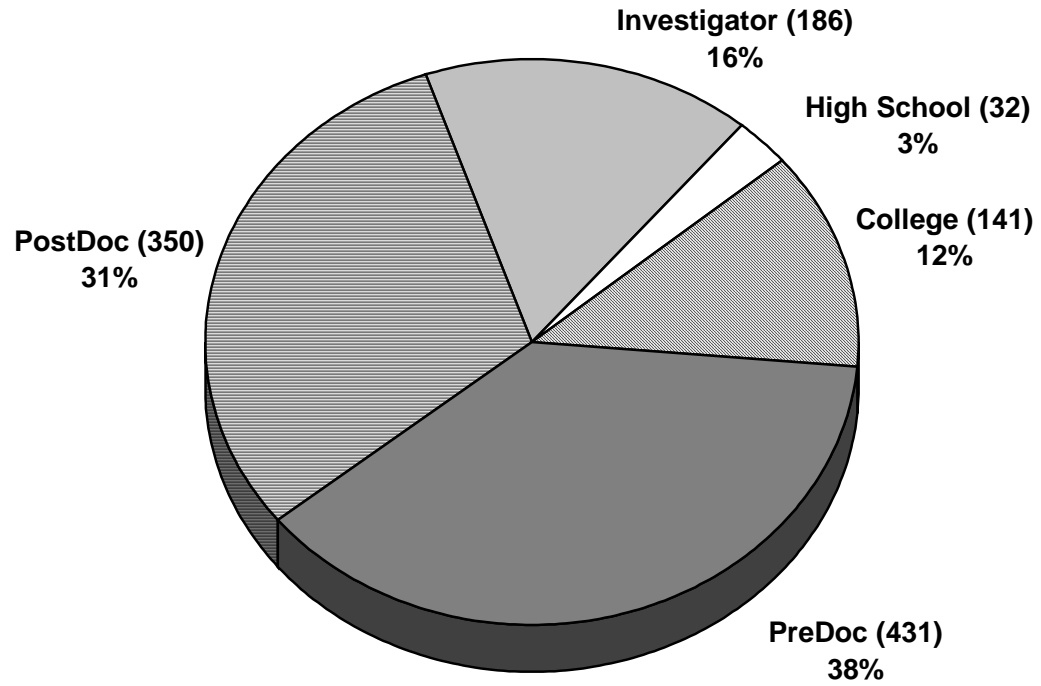

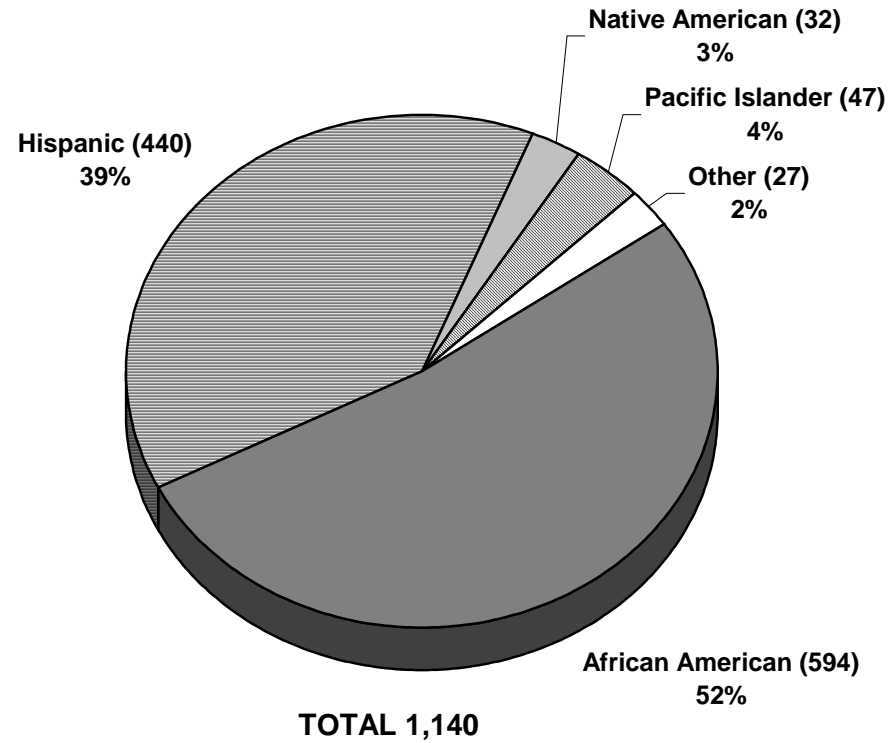

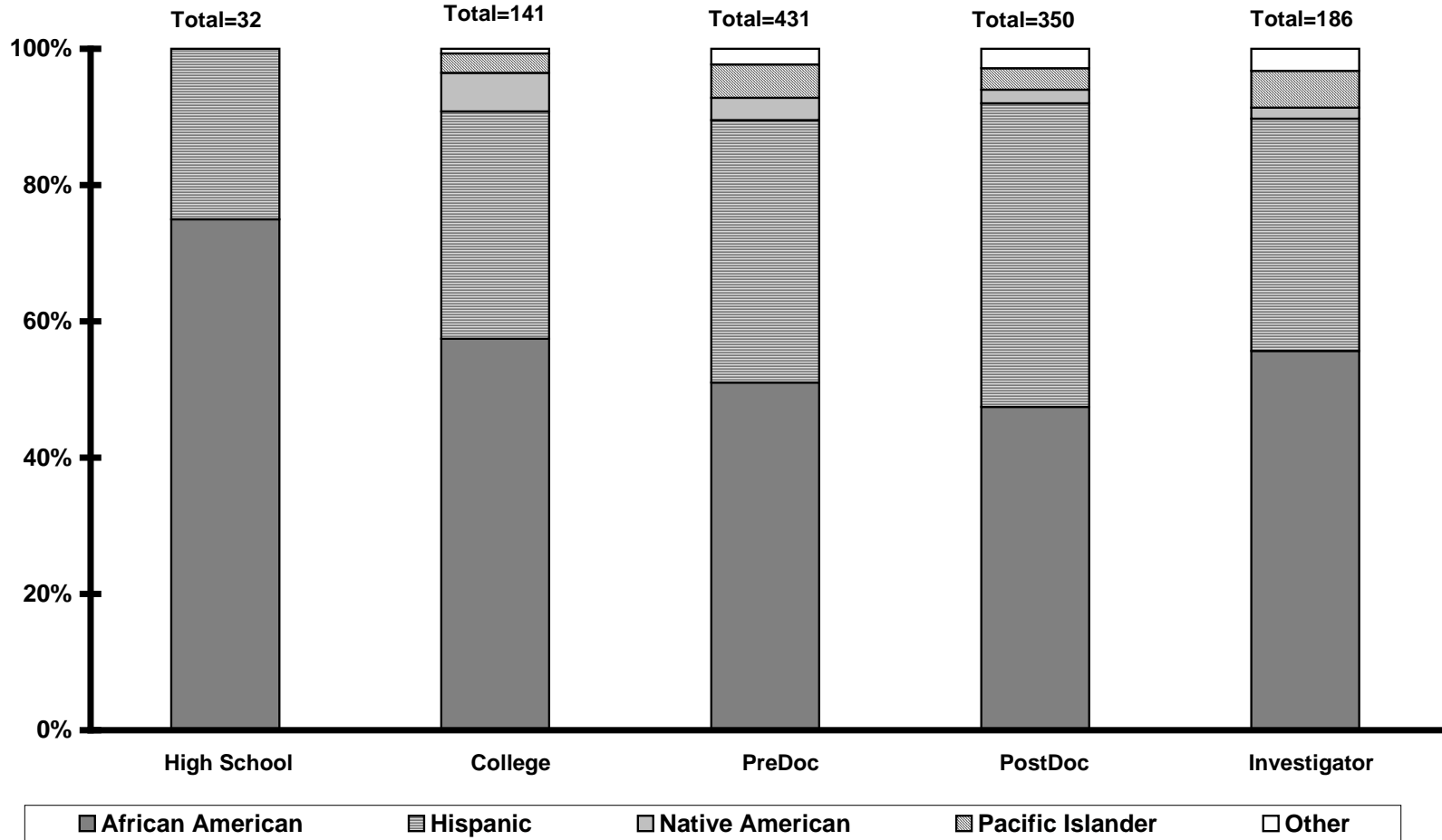
**RACIAL/ETHNIC CLASSIFICATION OF INDIVIDUALS

FISCAL YEAR 1998**



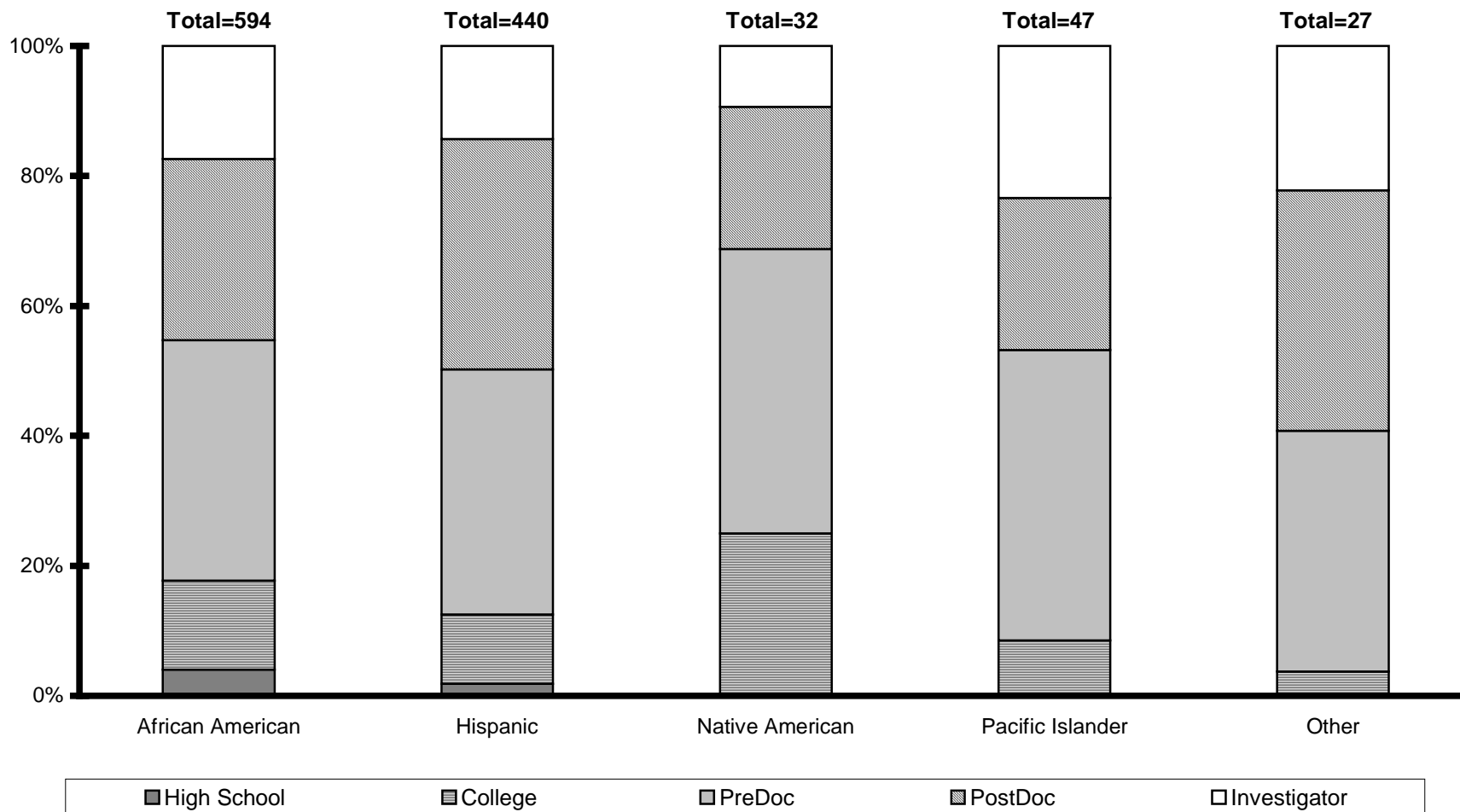

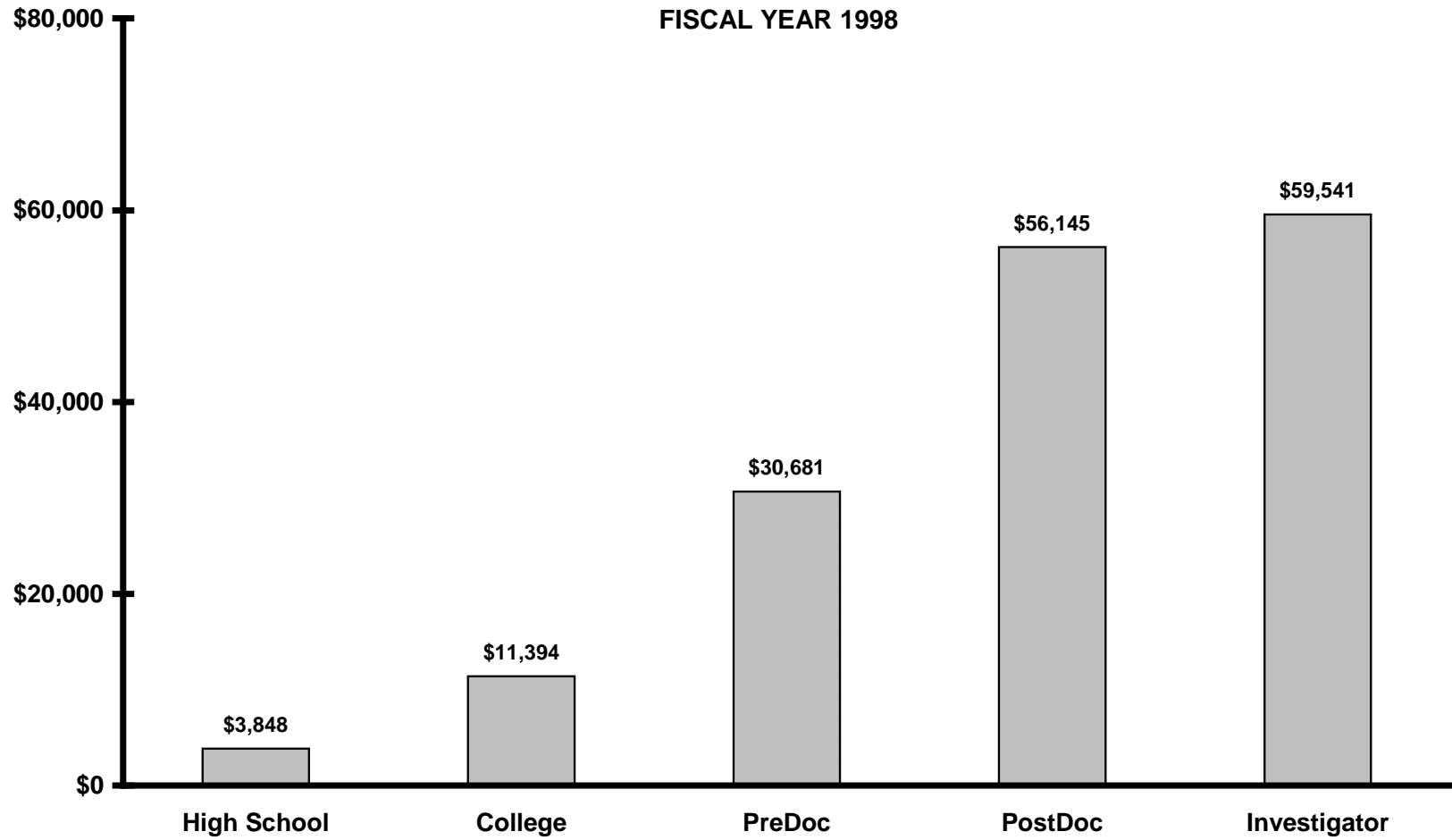

AVERAGE TOTAL COST OF MINORITY SUPPLEMENTS FISCAL YEAR 1998

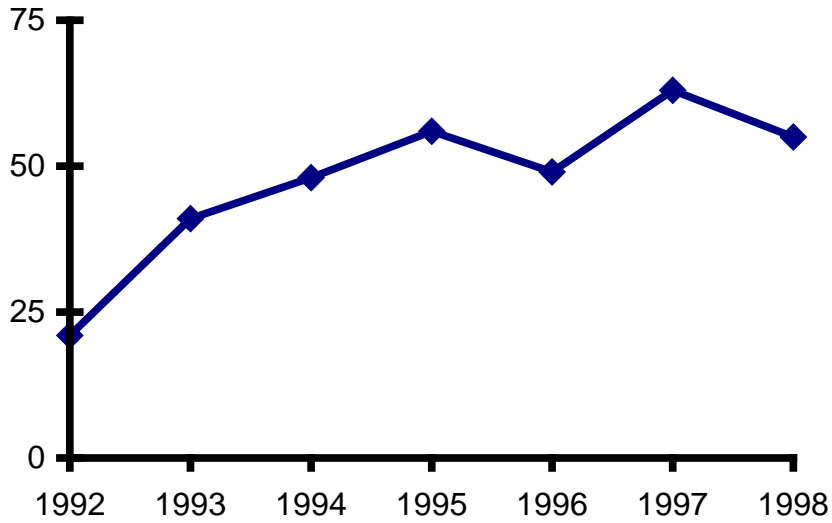

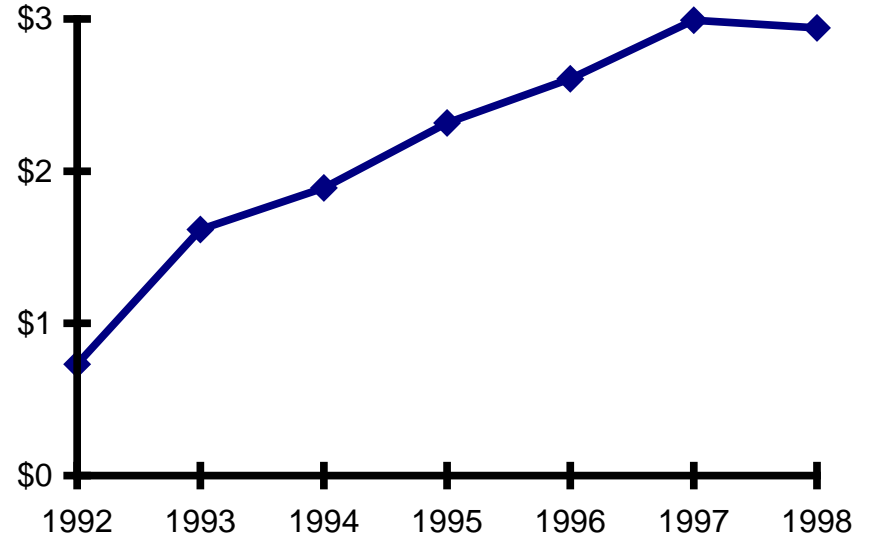
