Small businesses prove their big worth at SBA Awards Girgis recognized as Person of the Year

Hany Girgis' company was founded in his guest bedroom, but **SkillStorm Inc.** now reaches the Pentagon, the Department of Defense and the U.S. military. In recognition of the company's growth, Girgis was named Small-Business Person of the Year at the annual San Diego Small Business awards luncheon Thursday.

The award ceremony recognized local smallbusiness leaders for their success and contributions to the community. It was held at the San Diego Marriott Hotel and Marina downtown and hosted by the San Diego Regional Chamber of Commerce and Small Business Administration.

Keynote speaker and SBA Deputy Administrator Jovita Carranza described the award winners as "change agents."

"The common thread amongst all the award winners is that they have a passion for the service they're providing," Carranza said before the ceremony. "They have the tenacity to carry out their dreams. They make great sacrifices that other people wouldn't think of taking."

SCORE San Diego Chapter 140 received the first George Chandler Leadership Award, named in honor of former SBA San Diego district director George P. Chandler Jr., for its work in helping local businesses and contributing to national SCORE programs.

CPA firm **JGD & Associ**ates won the Chamber's North Island Credit Union "Excellence in the Work Environment Award."

Thomas Fitzpatrick, Deborah Helm and Fay Nakanishi of **The Mission North Park**, a restaurant specializing in California cuisine with Asian and Latino influences, was named Business Improvement District Business of the Year.

Other award recipients were recognized for customer service, community involvement, or for their roles as women, minority or veteran business owners.

The SBA has always placed a priority on underserved markets, including women, minorities and the economically disadvantaged, Carranza added.

It recently launched a new "Patriot Express" loan program, which provides loans to veterans, active-duty service members, Reservists and National Guard members, and spouses and widows of service members or veterans. The loans, which can be used for business purposes like start-up, expansion or equipment purchases, are available up to \$500,000, with SBA's maximum guaranty of 75 or 85 percent.

Before joining the SBA in December, Carranza worked as vice president of air operations at **UPS** (NYSE: UPS) for 30 years. The key ingredients to a successful business are the same for a multinational company such as UPS or a small, local business, she said.

"You need a solid business plan," she said. "A lot of knowledge about the market that you're trying to launch your product in is very critical."

She worked with small businesses in her roles at UPS and was surprised by how similar the two jobs were.

"The mission of UPS is to help small businesses grow, and that's the same philosophy as the SBA," Carranza said.

Girgis, who won the Business Person of the Year award,

said his company used SCORE and the SBA's help to get the certifications he needed to get off the ground.

Those organizations have "leveled the playing field" for small business competing against large corporations, he said.
