The Iowa Department of Agriculture and Land Stewardship (IDALS) under the Environmental Protection Agency's (EPA) Risk Management Program (RMP) Compliance Assistance Outreach is holding meetings on the implementation of Program 2 Risk Management Programs for Anhydrous Ammonia.

AGENDA Segment 1. The Complete Process of RMP. Presentation will follow the sequence in 40 CFR 68, the foundation of EPA's audit form which lowa adapted for its RMP reviews. Introduced will be web-based program myRMP, which was developed by EPA to assist in RMP development.

Emphasis will be on common weaknesses seen in the last two years of Iowa RMP reviews: (1) Offsite Consequence Analysis. (2) Maintenance Programs and Equipment Specifications. (3) Hazard Reviews. (4) Compliance Audits. (5) Workable Operating Procedures. (6) Documentation to support the dates in Section 8 of the submittal. (7) Communication with the local emergency planning committees and other emergency management personal.

Segment 2. Develop Your Current RMP Into a Compliant RMP. An explanation of requirements that make a RMP insufficient or out of date, i.e., change in the firm's name, emergency contact, or process. Instruction will include explanation of when it is time for a new hazard review or compliance audit. Demonstration will show how myRMP can be used for RMP improvement or to incorporate a segment into a RMP.

Segment 3. How to File a Submission, Resubmission, or Correction. Because the ability to make a submission online is expected February 2009, RMP*eSubmit will be introduced. Submittal websites, EPA's help websites, mailing addresses for CD submittal, EPA phone numbers, and IDALS contact information will also be provided.

If your firm has a RMP, chances are it is due for resubmission in **June 2009**. However, this meeting is open to anyone that wants to understand the RMP process.
