- (2) You will be asked to create two letter/number combinations for identification purposes.

- (9) Your receipt for payment will be returned stamped with your date to appear to be sworn-in. The date will be at least 10 days in advance. The ceremony is generally held in the courtroom of the Part 1 Judge on Tuesday mornings in New York.
- (10) In New York your sponsor <u>must</u> accompany you to your swearing-in ceremony. If you need to adjourn please call (212) 805-0645 by the Thursday before your ceremony date.
- (11) If your petition for admission to the bar is granted, your Electronic Case Filing (ECF) password will be sent to the email address on your application after you are sworn-in. Print and save your ECF password for future reference.
