SBA to Close Marksville Disaster Loan Outreach Center

SACRAMENTO – Michael W. Ricks, the U. S. Small Business Administration’s (SBA) Louisiana District Director, announced today that SBA’s Disaster Loan Outreach Center in **Marksville** will close on **Friday, December 19** at **6 pm**.

“SBA customer service representatives will continue to be available at the Disaster Loan Outreach Center to answer questions about SBA’s disaster loan program, explain the application process, help individuals complete their applications and close their approved disaster loans until then,” Ricks said. Residents and business owners who suffered damages as a result of Hurricanes Gustav and Ike can speak with SBA representatives on the days and times indicated below until the office closes. No appointment is necessary.

“Although the deadline to apply for property damage from Hurricane Gustav was December 3, small businesses and most, private non-profit organizations affected by Hurricane Gustav have until June 2, 2009 to apply for Economic Injury Disaster Loans (EIDL). These loans are designed to help meet working capital needs caused by the disaster. EIDL assistance is available regardless of whether the business suffered any property damage. For victims of Hurricane Ike, the filing deadline to return applications for property damage is January 12, 2009, and the EIDL deadline is June 15, 2009.

Since the President declared the hurricanes disasters, SBA has approved \$122.1 million in loans to 3,823 Louisiana homeowners and renters and \$23.9 million in loans to 479 Louisiana businesses and private, non-profit organizations hurt by Hurricanes Gustav and Ike,” said Ricks.
