

This Final Environmental Impact Statement (FEIS) for Navajo Reservoir Operations has been prepared in compliance with the National Environmental Policy Act (NEPA). It has been prepared by the Department of the Interior through the Bureau of Reclamation (Reclamation) and in cooperation with the following: Bureau of Indian Affairs; Bureau of Land Management; Corps of Engineers; Environmental Protection Agency; Federal Energy Regulatory Commission; Fish and Wildlife Service; National Park Service; Jicarilla Apache Nation; Southern Ute Indian Tribe; Navajo Nation; Ute Mountain Ute Tribe; Colorado Water Conservation Board; New Mexico Department of Game and Fish; New Mexico Interstate Stream Commission; New Mexico Environment Department; City of Farmington; San Juan Water Commission; and Southwestern Water Conservation District.

The FEIS evaluates the potential impacts of implementing the San Juan River Basin Recovery Implementation Program's Flow Recommendations for the San Juan River (Flow Recommendations) (1999) or a reasonable alternative to those recommendations. To accomplish this action, Reclamation would continue to operate Navajo Dam to meet authorized project purposes while modifying reservoir release patterns to meet Flow Recommendations designed to maintain or improve habitat, in concert with the San Juan River Recovery Program, for the razorback sucker and Colorado pikeminnow.

Seven alternatives were evaluated in the FEIS. Most of the alternatives formulated for evaluation are described in term of flow rates representing minimum and maximum limits in cubic feet per second in the range of release rates from Navajo Dam.


