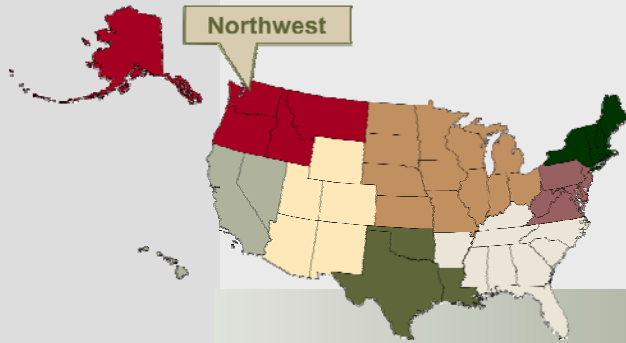


# Northwest CHP Regional Application Center

### About Us

#### *Mission*

The Northwest CHP Application Center assists organizations with CHP projects that are economically viable and make efficient use of energy.

#### *Objectives*

The Northwest CHP Application Center covers the states of Alaska, Idaho, Montana, Oregon, and Washington. Its headquarters is in Olympia, WA, and is part of the Washington State University (WSU) Extension Energy Program.

The Northwest CHP Application Center is one of eight regional application centers. It works in partnership with DOE's Distributed Energy Program and the other regional centers. The Northwest CHP Application Center has strong state-based efforts (see State Contacts listed on <http://www.chpcenternw.org>).

Areas of focus and expertise include:

- ★ Industrial CHP operated in cooperation with the Department of Energy's Industrial Technologies Program (especially forest products and food processing)
- ★ Opportunity fuels are targeted for projects including biogas, hog fuel and waste heat
- ★ District energy systems including HeatMapCHP software that is the international standard for district energy system design and re-design
- ★ Target markets vary in the region but include forest products, dairy and feed lot operators, food processing, wastewater plants, micro-grids, and waste heat industrial
- ★ Support of the CHP initiative and the legal, institutional, and regulatory aspects of CHP
