Exelon clarified the scoping and screening process as shown in Figure 2.1-1 of the Peach Bottom license renewal application. They discussed five reasons for categorizing components associated with non-safety related systems to systems determined to be within the scope of license renewal. Examples illustrative of the reasons were presented and discussed.

The NRC staff shared its concerns regarding Exelon's methodology for scoping and screening of systems, structures and components that are within the scope of license renewal. The NRC staff was also concerned about how the methodology was used to determine the results of the scoping/screening process. The NRC staff advised Exelon of its intent to issue a request for additional information (RAI).
