

Licensee's General Comments: On November 30, 2005, a locked high radiation area was not secured against unauthorized access. Personnel failed to properly secure the 80-foot containment airlock after an immediate egress of personnel from the RCA as a result of a personnel illness. The air lock was verified not to have been opened during the time the airlock was not secure. Therefore, no personnel exposures were incurred. The PI remained within the Green band.

Unplanned Scrams per 7000 Critical Hrs



Scrams with Loss of Normal Heat Removal



Unplanned Power Changes per 7000 Critical Hrs



Safety System Unavailability, Emergency AC Power, >2EDG







Safety System Unavailability, Residual Heat Removal System







Reactor Coolant System Activity







ERO Drill Participation





Occupational Exposure Control Effectiveness


