



Food Crisis... Definition

Level 1 ROUTINE

Low risk characteristics

Limited food distribution

Easy to control by one official agency

Level 2 MAJOR

Medium to high risk Characteristics

Wider food distribution

involves

More than one
Government
agency

Level 3-CRISIS

High risk characteristics

Wide scale food distribution

Capacity to control is **Beyond** ADFCA

Need Extra resources

Apply To L- 3 Incidents

Food Crisis... Cases

Cases to Initiate Crisis Action plan:

- * Large scale chemical contamination of food;
- * Serious food microbiological contamination;
- * Intentional/malicious food contamination;
- * Investigations into a food incident indicating larger scale problem
- * Activation of another Government Agency emergency or contingency plan
- * Notifications from INFOSAN (International Food Safety Authorities Network) or other international food alerts

Crisis Plan... Purpose

Describe measures required to ensure ADFCA is ready to respond effectively and in a timely manner

 Roadmap procedures when ADFCA is notified of a serious food safety hazard involving food manufactured or marketed in Abu Dhabi



Crisis Management Team

Responsibilities:

- Gather and evaluate available information
- · Identify Hazards and Assess Risk
- Initiate Action to the Crisis plan
- Initiate risk assessment &/or Investigation
- Decide Risk Management activities
- Identify Expertise / Technical Staff
- Identify stakeholder groups to be involved
- Request further information as necessary
- Prepare Crisis Briefing
- Communicate with Stakeholders incl. Media


Abu Dhabi Electricity and Water Authority

Provide Information on water quality and potential risks to public health including Water Intake Production sites

Ministry of Health-Federal

Inform ADFCA on any Outbreak/Illness case (s) associated with Food. Thus ensuring coordinated national response to Crisis in a timely manner


Crisis Management Plan- Workflow



Details... When Collecting Information

- Reporter details
- Type of Food including brand name
- Pack size
- Durability (best before/use by dates)
- Lot/Batch number
- Origin/Distribution of the food
- Nature of complaint/hazard
- Premises involved full address
- Details of illness/ symptoms associated with consumption and onset times/dates
- Any actions already taken
- Results of any analysis already undertaken.

Crisis Management Plan- Workflow




Crisis Team Coordinator

* Role of Coordinator:

Initiate / activate the plan
Contact all Crisis Team members
Arrange the first meeting of Crisis team
Brief the Crisis team on circumstances

- * Crisis Team Coordinator Acts as The Chairperson for Crisis Management Team
 - ADFCA Director General
 - Or ADFCA Assistant Director General
- * Minutes of meetings will be taken by Secretariat with note of actions & decisions.

Crisis Management Plan- Workflow



Need for Risk Assessment

Factors to Consider the Need for Risk Assessment during Crisis:

- Impact on Human Health
- Hazard Characterization
- Nature of Food
- Scale of Distribution
- Consumption Rate
- Targeted Consumers
- Time Pressure

Role of Press Officer

ADFCA Communication & Information Manager

- Prepare Media Statements for the Crisis Management Team
- Brief Crisis Management team on Information Requests & Communication Strategy and Needs
- Liaise with the Press on Crisis updates
- Prepare Information for publishing on the Website & Help-line

Closure and Reporting

Crisis Team will

Decide crisis is over and deactivate the plan

Report the outcome of the team activities to all dealing with the crisis

Towards The Future

- Rapid Alert Automated System:
 - Archiving database design (Document & Trace History)
 - ✓ Integrated with "Food Imports" and "Local Market Inspection" Automated systems
 - ✓ Dynamic Reporting Module
 - ✓ Web-enabled
 - Automatic Calls Diversion & Recording
 - ✓ Automatic Distribution List
