N.L.R.B. ELECTION REPORT

CASES CLOSED OCTOBER 2000

NOTE: This monthly report lists the outcome of secret-ballot voting by employees in NLRB-conducted representation elections as officially certified following resolution of post-election objections and/or challenges. During FY 2001, the NLRB continued to improve its techniques for tracking and collecting case activity data.
