MESSAGE FROM THE CHAIRMAN

As the summer months continue, personal and recreational boating is a favorite American pastime. It is important to remember safe boating rules -- "don't drink and drive, avoid excessive speed, wear a personal flotation device and be aware of the basic boating rules and responsibilities."

Last year there were more than 700 deaths in boating accidents. This year, two of our major accidents are marine investigations: the explosion aboard the cruise ship *Norway* and capsizing of the small passenger vessel *Taki Tooo*. The Board is dedicated to safety in all modes of transportation and will

work diligently with the US Coast Guard and marine associations on education and outreach activities to promote marine and boating safety.

Vice Chairman Rosenker has focused on recreational boating safety issues, recently speaking at the Personal Flotation Device Manufacturers Association (PFDMA) conference in Florida and testifying before the Natural Resources Committee of the Wisconsin State Assembly on a pending bill that would require personal flotation device use by children aboard recreational vessels.

As a "live-aboard' boater, I personally share in the joy of a wonderful lifestyle. I hope we can continue to ensure that safety comes first.

NTSB AND NASBLA AGGRESSIVELY PURSUE BOATING SAFETY

Chairman Engleman met with the National Association of State Boating Law Administrators President Alvin Taylor (South Carolina Boating Law Administrator) and Executive Director George Stewart to discuss recreational boating safety issues. "Boats are social vessels" said Chairman Engleman, referring to the 12 million recreational boats and 70 million boaters in the US. But she also noted that "sometimes boaters

unintentionally put their most important treasures, their families, at risk." Thus, it is important to follow basic safety precautions, including that children wear life jackets and that boat operators know the rules of the road." The Chairman and NASBLA President agreed to work together to introduce some boating safety training courses at the Academy.

Chairman Engleman will be speaking at the NASBLA annual meeting in September.

TSP Catch-Up Contribution Election—Beginning July 1st, eligible TSP participants were able to submit elections to make TSP Catch-Up contributions during the year 2003. TSP Catch-Up contributions are supplemental tax-deferred employee contributions, which are in addition to regular contributions. The elections will be effective the first full pay period in **August**. Eligible participants may make elections

whenever they desire; they are not limited to the TSP open seasons.

Employees may participate in the TSP Catch-Up contribution program if they are currently employed and in a pay status, age 50 or (50 by year end) and older, or contributing either the maximum TSP percentage and/or dollar amount allowed by his or her retirement coverage, and contributing an amount that will cause the employee to reach the yearly IRS elective maximum deferral limit by the end of that year. Any participant who is in a 6-month non-contribution period is not eligible to make TSP Catch-Up contributions during that time. If an employee terminates regular TSP contribution, the TSP Catch-Up contribution must be terminated. If the employee goes into a non-pay status, the TSP Catch-Up contribution will automatically stop.

The Congress is in recess until September 3rd. The Board continues to meet with Senate staff on our reauthorization and appropriations bills.

STATE OUTREACH ACTIVITIES

AAA Releases Distracted Driving Survey—The AAA Foundation for Traffic Safety released results of a survey of driver distractions, with a recommendation that state motor vehicle administrations adopt distracted driving language in their manuals. AAA estimates that distracted driving contributes to 25 to 50 percent of traffic fatalities. Its research also found that cell phone use is less common than a number of other driver distractions. Kevin Quinlan attended the press conference for SR and HS and provided HS with materials and a briefing. Col. James Champagne, Vice Chair of the Governor's Highway Safety Association and Governor's Representative in Louisiana, expressed unequivocal support for the Board's recommendations to the States on accident report forms and cell phone restrictions for teen novice drivers.
