MESSAGE FROM THE CHAIRMAN

I was pleased to hear U.S. Secretary of Transportation Norman Y. Mineta announce that the highway fatality rate and the total number of people killed on our roadways decreased significantly last year. We know that strong laws and high visibility enforcement work!

The National Transportation Safety Board has worked closely with the Department of Transportation, as well as our partners at AAA, the Airbag and Seat Belt Safety Campaign, Advocates for Highway and Auto Safety, The Century Council, the Insurance Institute for Highway Safety, MADD, and the National SAFE KIDS Campaign, to ensure that significant new highway safety laws have been enacted across the country and we will continue to do so.

Far too many people continue to be injured or killed in highway crashes - the leading cause of death for people under age 34. And 56% of those killed in passenger vehicles were not wearing their seat belts.

A reduction in highway deaths is very good news but our work is still not done. We must continue to promote state legislation to enhance the driving skills of teenage drivers and to ensure that children under 12 are buckled up in child safety seats and booster seats in the back of the car. And we must remove drinking drivers from our roads as drunk drivers still account for 20% of highway deaths.

Most importantly, we must enact primary enforcement seat belt laws in the remaining 29 States who have not chosen to adopt the single greatest life-saving measure available. It is critical to raise our seat belt use rate to levels comparable to those in Australia, Canada, and many European nations. America's leadership in highway safety is not yet established but we're going in the right direction.

Team Launches to Cargo Aircraft Accident

An NTSB go-team launched to the crash of a cargo aircraft that occurred on the morning of August 13th. Preliminary reports indicate that, at 12:50 a.m. Friday, an Air Tahoma Convair 580 reported engine trouble before crashing onto a golf course short of runway 36R at the Cincinnati/Northern Kentucky International Airport. The flight was arriving from Memphis, Tennessee. One crewmember was killed in the crash; the other was reported to be in serious condition.

Joseph Sedor is the Investigator-in-Charge of the accident. He is accompanied by a team of nine investigators. NTSB Member **Carol Carmody** is accompanying the team and will serve as principal spokesperson for the on-scene investigation.

Participants included local fire department personnel, law enforcement officers, NTSB staff, coroners, emergency management staff, airport operations management, representatives from TSA and Aircraft Rescue and Fire Fighting personnel. Course attendance included 49 participants from 19 states. A five member panel, which discussed real-world response to major transportation events, closed the course. Panelists
