Large domestic banks constitute a universe; data for small domestic banks and foreign-related institutions are estimates based on weekly samples and on quarter-end condition reports. Data are adjusted for breaks caused by reclassifications of assets and liabilities.

The data for large and small domestic banks presented on pages 5 to 10 are adjusted to remove the estimated effects of mergers between these two groups. The adjustment for mergers changes past levels to make them comparable with current levels. Estimated quantities of balance sheet items acquired in mergers are removed from past data for the bank group that contained the acquired bank and put into past data for the group containing the acquiring bank. Balance sheet data for acquired banks are obtained from call reports, and a ratio procedure is used to adjust past levels.

2. Treasury securities are liabilities of the U.S. Treasury. Agency securities are liabilities of U.S. government agencies and U.S. government-sponsored enterprises.

Notes on the Data

Large domestically chartered commercial banks acquired \$5.2 billion in assets and liabilities of nonbank institutions in the week ending April 18, 2007. The major asset items affected were (in billions): Treasury and Agency securities, investment account, \$0.6; real estate loans, revolving home equity, \$0.3, real estate loans, commercial, \$1.6; real estate loans, other residential, \$1.3; commercial and industrial loans, \$0.4; cash assets, \$0.1; and other assets, \$1.0. The major liability items affected were: transaction deposits, \$1.3; nontransaction deposits, large time, \$0.4; nontransaction deposits, other, \$1.7; borrowings from banks in the U.S., \$0.5; borrowings from others, \$0.2; other liabilities, \$0.1; and residual (assets less liabilities), \$1.0. The memo item affected was: mortgage-backed securities, pass-through, \$0.5.
