Dear Director Rogan:

This is in regard to the patent term extension application for U.S. Patent No. 5,514,650 filed by Merck & Company under 35 U.S.C. § 156. The patent claims Cancidas (casprofungin acetate), NDA 21-227.

In the February 19, 2003, issue of the Federal Register (68 Fed. Reg. 8028), the Food and Drug Administration published its determination of this product's regulatory review period, as required under 35 U.S.C. § 156(d)(2)(A). The notice provided that on or before August 18, 2003, 180 days after the publication of the determination, any interested person could file a petition with FDA under 35 U.S.C. § 156(d)(2)(B)(i) for a determination of whether the patent term extension applicant acted with due diligence during the regulatory review period.

The 180-day period for filing a due diligence petition pursuant to this notice has expired and FDA has received no such petition. Therefore, FDA considers the regulatory review period determination to be final.
