Re: Notification for Statements on Dietary Supplement Labeling

To Whom It May Concern:

This notification is being submitted on behalf of Unicity Network, Inc., Orem, Utah, a distributor of dietary supplement products (hereinafter "Unicity").

Pursuant to the requirements of Section 6 of the Dietary Supplement Health and Education Act of 1994, 21 U.S.C. § 343 (r) (6), and in accordance with the authorized provisions of 21 CFR § 101.93(a), your Agency is hereby notified that Unicity has made the following structure function statements, as described in 21 U.S.C. § 343 (r) (6) (A), for its dietary supplement product, *EnRich & Thin™ Chocolate Diet Capsules*, as follows:

- (1) Active compounds found in cocoa and chocolate, which come from the cacao bean include alkaloids that stimulate metabolism and antioxidants that support cardiovascular health. The cacao bean also contains serotonin, PEA (a potential mood elevator), and other compounds believed to produce feelings of euphoria, suppress the appetite, and deliver other health benefits.
- (2) Unicity's EnRich & Thin™ Chocolate Diet Capsules feature Chocolate Rx™, a proprietary blend of green tea, the rainforest herb guarana, and CocoLean™, a newly developed extract from the cacao bean. Formulated to provide a powerful thermogenic aid to anyone's diet and exercise program, EnRich & Thin™ Chocolate Diet Capsules are the foundation for a convenient and flexible weight loss system.
