"Dear Colleague" Letter on August 13, 2001 Public Meeting on the Labeling of Foods Containing Allergens

Dear Colleague:

This letter is to alert you that the Food and Drug Administration (FDA) will be holding a public meeting on August 13, 2001, in Washington, DC, to discuss the labeling of foods containing allergens and the

inadvertent addition of allergens to foods due to processing practices. The purpose of the meeting is to stimulate discussion and to obtain information to assist FDA determine what additional actions may be necessary to provide consumers with adequate information on product labels. The meeting will focus on three areas: (1) source or plain English labeling; (2) supplemental labeling (e.g., "may contain" labeling); and (3) labeling of ingredients exempted from declaration (i.e., common or usual names of flavorings, spices, and colors; incidental additives). A Federal Register notice detailing the background for the meeting, specific issues, logistics, and registration information will be published shortly.
