APPLICATION FOR DEFERRAL (REQUEST FOR WITHDRAWAL)

Re: Withdrawal of Request for Deferral from 21 CFR 201.66 (OTC Drug Product Labeling)

Subject: L. Perrigo Company (Perrigo)
Suphedrine Cold & Cough Liquid-Filled Capsules (Perrigo code 080)
Day Time Liquid-Filled Capsules (Perrigo product code 389)

Pursuant to 21 CFR 201.66(e) Perrigo requested a Deferral from 21 CFR 201.66 for its Suphedrine Cold & Cough Liquid-Filled Capsule over-the-counter drug product (Perrigo product code 080) and Day Time Liquid-Filled Capsules (Perrigo product code 389). The requests were sent to Docket No. 98N-0337 and were dated August 9, 2001. Perrigo requested that the Food and Drug Administration defer compliance until Exemption Requests dated October 6, 2000 had been answered regarding the use of the phrase "May contain" in the inactive ingredients section of the product label.

On November 6, 2001 Perrigo received a response to the Exemption Requests from the Food and Drug Administration. At this time, Perrigo requests the withdrawal of both Deferral requests dated August 9, 2001 regarding Suphedrine Cold & Cough Liquid-Filled Capsules (Perrigo code 080) and Day Time Liquid-Filled Capsules (Perrigo product code 389).

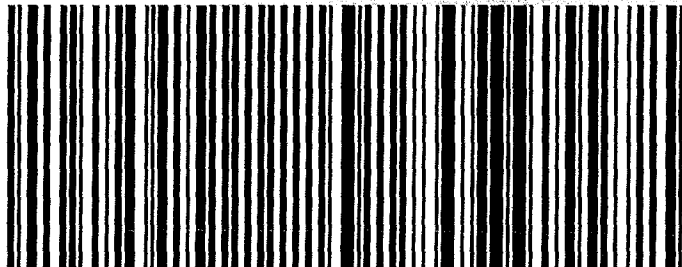
