Integrated Safety Management (ISM) Best Practices Workshop

This memorandum is to announce that we will have an ISM Best Practices Workshop on September 12-13, 2006 in Aurora (near Denver), Colorado. The purpose of this workshop is to provide a structured forum for DOE facilities to share best practices in key areas focusing on improving ISM system effectiveness, as well as developing execution plans for raising the Department's safety performance. This workshop will focus on the following topical areas:

- 1. Work Planning and Control
- 2. Feedback and Improvement/Corrective Action Management Systems
- 3. Integrating Safety into Design & Construction
- 4. Measuring ISM System Effectiveness
- 5. DOE Safety Management and Oversight

Senior DOE and contractor managers will be leading the coordination and making arrangements for the topics, as shown in the draft agenda.

To ensure the effectiveness of this workshop, we need your office and your contractors to share ISM best practices at your facilities. The Richland Operations Office (RL) and the Office of River Protection (ORP) in the DOE Office of Environmental Management are co-sponsoring this workshop. A draft agenda, which was discussed at the recent ISM Champions conference call on May 25, is attached for your information.

As noted in the draft agenda, we also plan to have parallel meetings on the afternoon of September 11, one for DOE ISM Champions and one for contractors' ISM leaders, to discuss ISM implementation issues. In addition, Human Performance Improvement training courses will be offered on September 11 and September 14.

All DOE ISM Champions and paper presenters are requested to participate in the workshop. DOE and contractor site managers are encouraged to attend and they will determine their staff's attendance, based on the subject matters to be discussed and addressed. Organizational focus, resource constraints and cost factors should also be considered.
