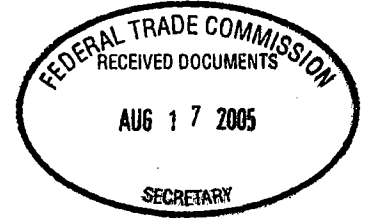

The parties hereby file their ninth joint status report relating to the status of Mr. Chhabra's sentencing in his criminal matter and of settlement negotiations in this case.


Complaint Counsel's Statement

At a sentencing hearing on Friday August 12, 2005 the judge in Mr. Chhabra's criminal proceeding sentenced him to 33 months of incarceration. Also, since the filing of the last status report in this matter, the parties met at length to discuss a possible settlement of this matter. We believe that an agreement has been reached on the terms of a consent agreement, and have prepared appropriate papers for signature. Once the agreement has been executed, the parties will file a joint motion to withdraw the matter from adjudication. Accordingly, complaint counsel does not seek issuance of a revised scheduling order at this time.


Statement of Counsel for Respondents
