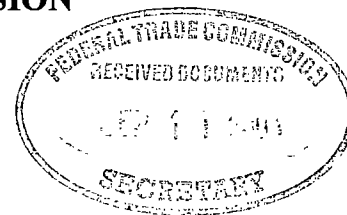



**STIPULATION AND (PROPOSED) ORDER
REGARDING CLOSING ARGUMENT**
