DEADLINES FOR HEARING ACTIVITIES -- 10 CFR PART 2, SUBPART M

Subpart M hearing procedures apply to proceedings for the transfer of a materials or reactor license. The Commission issues Subpart M is the only mechanism for requesting hearings on license transfer requests unless contrary, case-specific orders. Subpart M hearings can take the form of either oral hearings or hearings consisting of written comments. This guide is not a replacement for the procedural regulations in 10 CFR Part 2. To the extent users rely on this guide, they do so at their own risk.
