2/ The Mandatory and Matching allocations are final based on the Deficit Reduction Act. The Matching allocation includes reallocated funds in FY 2006.

3/ The Discretionary allocations are final based on the FY 2006 Discretionary appropriation (P.L. 109-149) which includes a 1.0% reduction across-the-board to most Federal Discretionary programs and a \$1,416,520 reduction authorized by Section 208 of the Labor, HHS, and Education and Related Agencies Appropriation Act, 2006.

4/ Totals are the sum of Discretionary, Mandatory and the Federal Share of the Matching Funds.

5/ The FY 2006 Discretionary appropriation set-aside \$982,080 (after rescission) for a toll-free child care hotline to be operated by Child Care Aware and specified that the amount come out of the \$18.8 million earmark for resource and referral and school-age child care activities.
