- 1) **H.R. 1463** - Small Pox Vaccination Compensation Fund Act (Burr - Energy & Commerce)
- 2) **H.Con.Res. 58** - Honoring the City of Fayetteville, North Carolina, and its many partners for the Festival of Flight, a celebration of the centennial of Wilbur and Orville Wright's first flight; the first controlled, powered flight in history (Etheridge - Gov't Reform)
- 3) **H.R. 1208** - Northern Ireland Peace and Reconciliation Support Act of 2003 (C. Smith, Hyde, King, Crowley, Payne, Walsh, Neal - HIRC)
- 4) **H.Res. 149** - Expressing condolences on the assassination of the Serbian Prime Minister (Bereuter, Emmanuel, Hyde, Lantos - HIRC)
