

Further to your phone enquiry of July 28 and our discussion today, I am enclosing three items of information for your distribution to members of the Dental Products Panel and the Drug Advisory Committee prior to your forthcoming meeting of Sept. 6-7, 2006. these items are:

- 1. An invited review of relevant background literature on the uptake, distribution, metabolism, and pathophysiological effects of amalgam mercury (FASEB Journal 9:504-508, 1995).
- 2. A research paper demonstrating how mercury causes brain neuron degeneration (NeuroReport 12: 733-737, 2001).
- 3. A copy of my invited testimony on mercury toxicity and dental amalgam before a congressional subcommittee (sworn statement, May 8, 2003).



### To whom it may concern:

I am writing to you regarding heavy metal/mercury poisoning. As you may know amalgam fillings contain approximately 50% mercury and they are under suspicion of causing disease by many countries, including Sweden and Germany. The Canadians have won a class action lawsuit which would grant amalgam replacements. Mercury is the most toxic heavy metal, more toxic than lead or arsenic.

This is a personal issue to me. I was acutely poisoned with mercury when as a child a bottle of Mercurochrome was poured very slowly into a large deep wound. I experienced a severe case of hives, I was very irritable, and was hospitalized with hot inflamed joints including my ankles, knees and hands. I was unable to walk because I had very poor balance for several months following this poisoning. Poor balance has haunted me to this very day, as do aching joints and muscles. When I was 11 years old I had my first amalgam filling. I suffered from extreme fatigue. At 27, I had 2 mercury fillings placed. I was not asked about any previous exposure to mercury. I was not told that the filling was 50% mercury. I was diagnosed with MS having 3 small mercury fillings.

Someone who has had a history of mercury poisoning should never, ever have had an amalgam placed. But we were never told. In fact, I didn't know amalgam fillings even contained mercury. Any other consumer/trade organization would be required to inform us about the contents of their product. Why doesn't the dentist tell us about mercury in fillings? Since they don't ask us if we are sensitive to mercury or inform us amalgam has mercury in it, how can we/they tell? It just looks down right criminal. Has the FDA studied the mercury issue, so we can be informed of the health risk from mercury fillings? Why does the FDA protect the ADA from telling us what they are using? It just seems down right criminal. It almost appears that the FDA is working only for the ADA and not the American citizens.

I have NEVER had a symptom of MS without first being exposed to mercury (flu and tetanus vaccines and other medications containing thimerosal, paint, even fish). The symptoms of MS and mercury poisoning are identical. Could the elusive cause of Multiple Sclerosis be Mercury Sensitivity?

I fear that many more diseases could also be caused by mercury. All one needs to do is look at history and the science from many countries, and then consider the poor health of Americans,

children and adults. The lessons from Minamata, Japan, should never be forgotten (National Geographic, Oct., 1972; pg 507, *Quick Silver and Slow Death*). When the environment is added to this dilemma, as it was in Minamata Bay, it becomes a global disaster.

The fact that the FDA has ignored mercury exposure in America as well as in Americans is nothing less than a gross dereliction of duty. I thought the reason for the FDA in the first place was to protect our people and land. Mercury has been known to be a poison for quite some time now. Why has the FDA been silent so long when so many are suffering?
