**FEDERAL TRADE COMMISSION’S COMPLAINT
FOR INJUNCTIVE AND OTHER RELIEF**

Plaintiff, the Federal Trade Commission (“FTC” or “Commission”), for its Complaint alleges:

1. The FTC brings this action under Sections 5(a) and 13(b) of the FTC Act, 15 U.S.C. §§ 45(a) and 53(b), to obtain permanent injunctive relief, rescission or reformation of contracts, restitution, disgorgement, and other equitable relief for Defendant Zoilo Cruz’s deceptive acts and practices in violation of Section 5(a) of the FTC Act, 15 U.S.C. § 45(a).

JURISDICTION AND VENUE

2. This Court has subject matter jurisdiction over this action pursuant to 28 U.S.C. §§ 1331, 1337(a), and 1345, and 15 U.S.C. §§ 45(a) and 53(b). This action arises under 15 U.S.C. § 45(a)(1).

3. Venue in the United States District Court for the District of Puerto Rico is proper under 28 U.S.C. § 1391(b) and 15 U.S.C. § 53(b).

THE PARTIES

4. Plaintiff, the Federal Trade Commission, is an independent agency of the United States Government created by statute. 15 U.S.C. §§ 41-58. The Commission is charged, *inter alia*, with enforcement of Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), which prohibits unfair or deceptive acts or practices in or affecting commerce. The Commission is authorized to initiate federal district court proceedings, by its own attorneys, to enjoin violations of the FTC Act, and to secure such equitable relief, including rescission of contracts, restitution, and disgorgement of ill-gotten monies, as may be appropriate in each case. 15 U.S.C. § 53(b).

5. Defendant Zoilo Cruz, also known as Zoilo Cruz Carrion (“Defendant”), is an individual doing business as International Marketing. At all times material to this Complaint, acting alone or in concert with others, Defendant has formulated, directed, controlled, or participated in the acts and practices set forth in this Complaint. Defendant transacts or has transacted business in the District of Puerto Rico.

COMMERCE

6. At all times material to this Complaint, Defendant has maintained a substantial course of trade in or affecting commerce, as “commerce” is defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

DEFENDANT’S BUSINESS PRACTICES

7. Defendant, doing business as International Marketing, has advertised, offered for sale, or sold a work-at-home opportunity to consumers throughout the United States, including consumers in the District of Puerto Rico.

8. Defendant has promoted his work-at-home opportunity through print classified advertisements, including advertisements in Spanish language newspapers such as *El Nuevo Día*, and through an Internet website, www.internationalmarketing123.com.

9. In his print classified advertisements, Defendant has represented, expressly or by implication, that consumers can make substantial amounts of money by working from home.

For example, typical advertisements state:

TRABAJE EN CASA - Le dedico mas tiempo a mis hijos todo los dias!
Gane Dinero extra \$500-\$1,500.
PO Box 43001 Dept. 486 Rio Grande PR 00745-6600 o a internationalmarketing123.com

Translation:

WORK AT HOME – I devote more time to my children every day!
Earn Extra Money. \$500 - \$1,500.
PO Box 43001 Dept. 486 Rio Grande PR 00745-6600 or at internationalmarketing123.com

10. On the www.internationalmarketing123.com website, Defendant has represented, expressly or by implication, that consumers are likely to earn a substantial amount of money for stuffing envelopes. The April 10, 2008 version of www.internationalmarketing123.com, attached hereto as Exhibit B (“the website”), contains the following representations:

¿Rellenarías 80 sobres para ganarte \$1,400 semanales? ¿Serian \$17.50 por cada sobre que rellenes con nuestros folletos! . . . Ahora Puedes ingresar al EQUIPO DE TRABAJO CON EL PAGO MAS ALTO de preparación de sobres.

Tu pago ESTÁ GARANTIZADO en adelante por los sobres que rellenas. Tu trabajo es preparar sobres con materiales específicos y enviarlos a nuestra compañía. No hay límite. Preparas tantos como desees. . . . De esta manera podrás pagar tus tarjetas de crédito, conseguir dinero para tus vacaciones, comprar un auto nuevo, un nuevo hogar o desarrollar esta segunda manera de ingreso para cualquier razón que puedas tener.

Exhibit B, pp. 5, 6.

Translation:

Would you stuff 80 envelopes to earn \$1,400 per week? That would be \$17.50 for each envelope that you fill with our flyers! . . . Now You can join the WORK TEAM WITH THE HIGHEST PAY for preparation of envelopes.

Your pay IS GUARANTEED in advance for the envelopes you stuff. Your work is to prepare envelopes with specific materials and send them to our company. There is no limit. You prepare as many as you like. . . . This way you can pay your credit cards, get money for your vacations, buy a new car, a new home or develop a second income for any reason you might have.

Exhibit B, pp. 23, 24.

11. On the website, Defendant has represented that consumers are likely to earn a substantial amount of money after paying only \$37, without incurring additional charges. The website contains the following representations:

Requerimos un solo depósito para su registro de solamente \$37.00.

4. ¿Habrá otras Cuotas (Costos Adicionales)?
Después de tu pequeño depósito, no se pedirá NINGÚN PAGO adicional.

Translation:

We require one single deposit to register, only \$37.

4. Will there be other Fees (Additional Costs)?

After your small deposit you will not be asked for ANY ADDITIONAL PAYMENT.

See Exhibit B, pp. 25, 30.

12. On the website, Defendant has represented, expressly or by implication, that International Marketing will pay consumers for each envelope stuffed. For example, the website represents that International Marketing will pay consumers \$17.50, \$25.00, or \$28.00 for each envelope stuffed, according to the number of envelopes consumers stuff and the length of their participation in the program. The following earnings representations appear on the website:

13. On the website, Defendant has represented, expressly or by implication, that International Marketing will provide all materials consumers need to earn money from Defendant's work at home opportunity. The website contains the following representations:

Te proveeremos los sobres, que serán estampados y con dirección.

Requerimos un solo depósito para su registro de solamente \$37.00. Este depósito de \$37.00 nos ayudará a conseguirle los materiales que necesita como empleado independiente de nuestra compañía.

See Exhibit B, pp. 9, 10.

Translation:

We will provide the envelopes, which will be stamped and addressed.

We require one single deposit to register, only \$37. This deposit of \$37 will help us to obtain the materials that you need as an independent employee of our company.

See Exhibit B, p. 25.

14. After consumers pay a \$37.00 fee, International Marketing sends consumers a sales pamphlet, titled "Incredible Home Mailing Program" ("IHMP"). The IHMP is in English only. See Exhibit C.

15. For the first time, the IHMP informs consumers that, instead of receiving envelopes and payment from International Marketing for stuffing envelopes, consumers must engage in one of two marketing schemes, both of which involve publishing advertisements to sell the IHMP itself. In other words, each scheme aims to have consumers publish advertisements to sell the same pamphlet Defendant sent them (i.e., the IHMP) to other consumers.

16. The first marketing scheme requires consumers to publish advertisements for the IHMP in newspapers at their own expense, and recommends that consumers open post-office boxes to receive responses to the advertisements, again at their own expense. The IHMP provides sample advertisements for consumers to publish:

\$100.00/Hour

Earn incredible income
from your own home!
FT/PT Job opportunity
Send \$4 and S.A.S.E.
to P.O. Box 2237, Long-
mont CO, 80502

\$1,000 Per WEEK

Get paid \$4 for every
envelope you stuff!
Send S.A.S.E. to H.M.
C. , P.O. Box 2237
Longmont, CO 80502

17. The IHMP informs consumers that, instead of being paid by International Marketing, consumers' income depends on other consumers responding to the advertisements discussed in the preceding paragraph.

18. If new consumers send self-addressed, stamped envelopes (i.e., S.A.S.E.s) and money in response to the new advertisements, the IHMP instructs the original consumers to keep the money, and to mail out a circular advertising the IHMP for an additional \$26.00 in the self-addressed, stamped envelopes. See Exhibit C, p.5. If new consumers order the IHMP, the IHMP instructs the original consumers to keep a portion of the \$26 sales price. See Exhibit C, pp. 5, 7.

19. The second marketing scheme also requires consumers to publish advertisements, but instructs them to include either a toll-free or local telephone number instead of an address. The IHMP instructs consumers to set up voicemail-boxes for the telephone numbers at their own expense to receive telephone calls from consumers who respond to the advertisements. See Exhibit C, pp. 8-9.

20. The IHMP instructs consumers to record a message in their voicemail-boxes advertising a \$26 envelope stuffing start-up kit (i.e., the IHMP). See Exhibit C, p. 9. The IHMP provides a sample message script for consumers to record. The script states that consumers have been successful in earning money before they have earned any money at all. The script specifically states:

Imagine earning four dollars for every envelope you stuff, seal, and mail! . . . Now I want you to completely understand this, if you are selected as a new associate, you will earn four dollars for every envelope you stuff with only one piece of paper.

You can secure your associate position for a one-time startup fee of only twenty six dollars.

In fact, this is probably the best financial opportunity of YOUR LIFE TIME. The Home Mailing Connection . . . [wants] you to become wealthy, the many success stories they receive from associates throughout the country is truly what motivates them to continue making this program available. **Take it from me, because I am personally one of those success stories!**

Exhibit C, p. 9 (emphasis added).

VIOLATIONS OF SECTION 5 OF THE FTC ACT

21. Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), prohibits unfair or deceptive acts or practices in or affecting commerce.

COUNT 1

22. In numerous instances, in the course of advertising, offering for sale, and selling a purported work-at-home opportunity, Defendant has represented, expressly or by implication, that:

- a. consumers are likely to earn a substantial amount of money for stuffing envelopes;
- b. International Marketing will pay consumers for each envelope stuffed;
- c. International Marketing will provide consumers with all materials they need to earn money from stuffing envelopes; and
- d. after paying \$37, consumers will not incur additional charges before earning money.

23. In truth and in fact:

- a. consumers are not likely to earn a substantial amount of money for stuffing envelopes;
- b. International Marketing does not pay consumers for each envelope stuffed;
- c. International Marketing does not provide consumers with all materials they need to earn money from stuffing envelopes; and
- d. after paying \$37, consumers do incur additional charges before earning money.

24. Therefore, Defendant's representations as set forth in Paragraph 22 are false and misleading and constitute deceptive acts or practices in violation of Section 5(a) of the FTC Act 15 U.S.C. § 45(a).

COUNT 2

25. By furnishing consumers with an instructions pamphlet that contains false and misleading representations, including, but not limited to, the false and misleading representations

set forth in Paragraphs 16 and 20, Defendant has provided the means and instrumentalities for the commission of deceptive acts and practices.

26. Therefore, Defendant's practices, as set forth in Paragraph 25, constitute deceptive acts and practices in violation of Section 5(a) of the FTC Act, 15 U.S.C. § 45(a).

CONSUMER INJURY

27. Consumers in the United States have suffered or are likely to suffer substantial monetary loss as a result of Defendant's unlawful acts or practices. In addition, Defendant has been unjustly enriched as a result of his unlawful practices. Absent injunctive relief by this Court, Defendant is likely to continue to injure consumers and harm the public interest.

THIS COURT'S POWER TO GRANT RELIEF

28. Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), empowers this Court to grant injunctive and other ancillary relief, including consumer redress, disgorgement and restitution, to prevent and remedy any violations of any provision of law enforced by the FTC.

29. This Court, in the exercise of its equitable jurisdiction, may award ancillary relief to remedy injury caused by Defendant's law violations.

PRAYER FOR RELIEF

WHEREFORE, the FTC, as authorized by Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), and the Court's own equitable powers, requests that the Court:

1. Enter a permanent injunction to prevent future violations of the FTC Act by Defendant;
2. Award such relief as the Court finds necessary to redress injury to consumers resulting from Defendant's violations of the FTC Act , including, but not limited to, rescission or

reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies; and

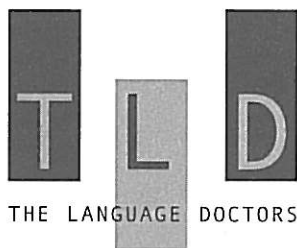
3. Award Plaintiff the costs of bringing this action, as well as such other and additional relief as the Court may determine to be just and proper.

The Vital Information You Will Need To Succeed Using Program #1:

Grab your phonebook, you will need to flip through the yellow pages, and under "Newspapers", you will find a long list of them that you will need to call, and write down important information about. Ask about their circulation, frequency of publication (Daily/Weekly etc.), and of course the price they will charge to print your classified advertisement. You should place your ad in at least 4 different newspapers to start, and do not spend much more than \$60.00 on all of them combined. If this unfortunately happens to be a lot of money from your perspective, and you can't pay it out of pocket at the moment, do not worry. Almost every newspaper will bill you at the end of the month, or even work out monthly payment plans to cover the cost, which gives you plenty of time to use your profits to pay the bill. When someone responds to your ad, you will find \$4.00, and a S.A.S.E. (Self-Addressed Stamped Envelope) in your P.O. Box (we will talk more about P.O. Boxes on page 8). When you get a response, take out your \$4.00 and the S.A.S.E., put our sales circular inside the S.A.S.E., and drop it right back in the mail. Using the S.A.S.E. method is how to avoid all postage and handling fees using this program. When the person reads the circular, they will then send \$26.00 to *you* so they can purchase our publication. You will keep \$20.80 of this (your 80% commission), and then simply write the customer's name on a drop-ship order form (on page 12), and mail the order form to us along with a check for our 20%, or \$5.20. We will then send your customer their publication, and take care of all the trouble and cost involved with doing so. Hundreds of small weekly newspapers around the country will charge you as little as \$15.00 or less to run your ad in their paper for 2 weeks. Now, carefully pay attention as we show you how simple math effectively demonstrates your absolutely shocking profit potential. A \$15.00 classified advertisement will likely be in a very small newspaper with a circulation close to only 4,000 people. Now, odds are that you could easily end up with much better results than this, but for the sake of demonstration lets say that the first week your ad runs, maybe only 40 people, or 1% of the total 4,000 person circulation, are even interested enough by your ad to send you a S.A.S.E. and 4 dollars. Now, $\$4.00 \times 40 \text{ people} = \160.00 . But wait! Remember the publication will print your ad for 2 weeks, and it is very likely that you will get the same if not a better response during the second week. So, $\$4.00 \times 80 = \320.00 . Then lets say that the circulars you send to these people generate a 40% sales rate. So, $40\% \text{ of } 80 = 32 \text{ people}$. $32 \times \$20.80$ (your 80% commission) = \$665.60. We promise to make them available for you to sell just as soon as they meet our strict requirements for reliability and effectiveness.

Step #2: Depending on your budget, simultaneously run the ad in as many inexpensive, low-circulation newspapers as possible. We recommend a minimum of 4, and conversely we also do not advise you to spend a ridiculous amount of money on your first series of ad placements. Remember, expand advertising in correlation with your profits and individual success. Put the ad in the jobs and careers, or business opportunities section.

Step #3: Take the currently available sales circular at the back of this publication to your local printing shop, and have them add your name and address in the box to the right of where it says "Clip And Mail To", in the bottom right corner. Then have them print up as many copies as you think you'll need to fill the responses of your first few ads. If you are really short on cash, you can even wait until you start receiving your S.A.S.Es., and use the money you earn from these to cover the cost.

Also, you will need to pay the added expense of purchasing local area-code voicemail boxes, or 1-800 numbers that are accessible free of charge nationwide. Although the cost of these numbers is minor (less than \$25.00 per month), if you choose to purchase more and more local-area code voicemail boxes for different advertising locations as we strongly recommend, the cost can slowly add up. However, since our personal experience as well as that of our current associates proves, you can expect making over 10 times the amount of sales that you could ever achieve from using the marketing method involved with using Program #1. This unbelievable increase in sales definitely cancels out the negative aspects of losing the \$4.00 for every S.A.S.E., and having to pay for voicemail boxes. This is because the minute they see a 1-800 number, they automatically assume they will be calling a huge national company who sells their program to thousands of people, and therefore decreases their individual chance of achieving success by having to deal with massive competition. However, if they see a familiar looking local area-code number, they are much more likely to actually call it because they will assume that the number goes to a individual person, or small local company that has just started providing this fantastic opportunity, and there is still time to get in at the very beginning, or "ground level" of this program, and



ride it's success to the very top. To get your local area code voicemail boxes or 1-800 numbers, call EFLS at 1-800-348-0500, and ask for *Robert Porter*. Make sure to tell him that you are an associate of Smart Publications, and that we recommended for you to call him. This man is managing this company, and we have worked out a deal with him so that all of our associates receive discounted rates on local area code voicemail boxes, as well as 1-800 numbers. This is just an example to give you an idea of what your message should sound like. You may choose to shorten this message, or lengthen it. You may choose to add some details about how extremely successful you have become, in only a short amount of time as our associate. Or, you can also just record this exact message. We will leave it up to you to experiment with the effectiveness of different types of messages. Again, always keep your advertising within the guidelines of what our program offers.
