

## **U. S. Department of Energy 2009 Cyber Security Conference**

### **Call for Conference Presentations**

Planning is underway for the 30<sup>th</sup> Department of Energy (DOE) Cyber Security Conference being held May 11-15, 2009, in Henderson, NV. This year's theme, *Beyond Compliance – Launch Pad for the Future*, focuses on developing and enhancing performance based cyber security while still maintaining compliance. As the mission of the Department evolves and numerous Federal regulations and departmental directives are implemented, cyber security professionals must continue the task of protecting information assets using cutting edge technology. This conference provides an excellent opportunity for DOE Federal and contractor employees to learn from industry experts, exchange information, and introduce cutting edge technologies.

The Program Committee is now accepting submissions of abstracts and speaker biographies for conference presentations or workshops. Presentations are limited to 50 minutes and training workshops can range from two hours to all day sessions. Proposals should address the following conference theme and tracks.

- Cyber Security and New Technology in Government – emerging technologies
- Cyber Security Technology Solutions
- Cyber Security Incident Management
- Cyber Security Training
- Cyber Security Basics
- Cyber Security Performance Assurance

Conference presentations and workshops will be held throughout the week of May 11-15, 2009. The agenda contains selected presentations, invited speakers from government and private industry, Town Hall (plenary) sessions, Coffee Talk sessions (Birds of a Feather) and vendor exhibits. Evening social events offer attendees a chance to network with other cyber security professionals from all levels of government and private industry. Conference attendees have a wide range of experience to include entry-level individuals as well as seasoned cyber security professionals.

Vendors planning to submit an abstract must be sponsored by a DOE Federal or contractor employee. Vendor presentations must focus on a certain technology or solution to a problem. The DOE sponsor must be present during the Vendor's presentation.

Abstracts and biographies must be submitted using the form in Attachment 1. The forms should be e-mailed to [cybersectrn@hq.doe.gov](mailto:cybersectrn@hq.doe.gov).

- February 13, 2009 – Presentations abstracts, pre-conference training workshop proposals, and speaker biographies due.
- March 6, 2009 – Announcement of presentation and pre-conference training workshop selection.
- April 17, 2009 – Presentations and speaker biographies due.
- May 11-May 15, 2009 – Conference and training workshops.
